Race 1 - 12:00 - THE PTP WELCOMES YOU CUP - [0 - 25] - 1600m (10 Runners)

General

1. Before the running of this race, the 990m camera was not working and the head on camera was in an alternate setting. These two issues were raised with the Mauritius Broadcasting Cooperation and were corrected before the running of the second race.

Starting Reports

- 1. HUDSON RIVER (J. Sophie) and INAUGURATION (M. Sonaram), which bumped leaving stalls, lost one length, respectively.
- 2. MASTEROFALLISURVEY (J. Allyhosain) was slow into stride.

Stewards Reports

- 1. The start of the race was reviewed pertaining to SPOTTED PEARL (S. Donohoe) drawn in stall gate 1. In this regard, it was established that this gate opened fractionally later than the others. However, when assessing this incident, the Board took note that this gelding did not suffer any prejudice as a consequence of this issue and had jumped on terms with the field. The matter was drawn to the attention of the Starter, Mr. R. Rawa, and the necessary measures were requested to be taken.
- 2. INAUGURATION (M. Sonaram) was baulked for a clear run between the 400m and the 300m.
- 3. THE HITMAN (K. Ramsamy) was hanging in from the 300m. In view of this report, the Veterinary Surgeon was requested to examine.
- 4. The saddle of HUDSON RIVER (J. Sophie) slipped forward in the running. This was confirmed by the Stipendiary Stewards on the viewing of the footage.
- 5. In view of the performance of MASTEROFALLISURVEY (J. Allyhosain), the Veterinary Surgeon was requested to examine.
- 6. Apprentice C. Goolgar (SPIRITUAL WIND) and Jockey M.Rashpassing (NAO FAZ MAL) appeared before the Board, were shown the patrol films of the race and advised against the practice of using the whip more than once on consecutive strides in the running. Apprentice C. Goolgar and Jockey M.Rashpassing were issued with a warning.



- 7. Apprentice N. Batchameah (SOCKEROO) appeared before the Board, was shown the patrol films of the race and advised against the practice of using his whip more than 7 times before the 150m. Apprentice N. Batchameah was issued with a warning. Additionally, Apprentice N. Batchameah signed an admission of guilt for a contravention of Rule 29.2.15, in that he used his whip down the shoulder of SOCKEROO, whilst in the drawn position. Accordingly, a penalty of a fine of Rs 3,500 was imposed on him.
- 8. After observing that a handler was not clear of the horses as the gates were opened, the Stipendiary Stewards reminded Starter R. Rawa of his obligation to ensure that all handlers are clear of the gates prior to effecting the start. Notwithstanding this incident, the Board was satisfied that no runner was impeded by this incident.

1. LE QUARTIER (I. Taka) and CHESTNUT COVE (J. Allyhosain) brushed.



Stewards Reports

 At the 900m, SUPREME ELEVATION (R. Kulloo) shifted out when awkwardly placed in respect of the running rail. In reaction to this movement, LE QUARTIER (I. Taka) was momentarily inconvenienced, took a hold, shifted out and carried out CHESTNUT COVE (J. Allyhosain). Additionally, the saddle of SUPREME ELEVATION slipped forward in the running. This was confirmed by the Stipendiary Stewards during the viewing of the footage.

In light of this being another ride with a delayed correction from Apprentice R. Kulloo, the Stipendiary Stewards are in the opinion that his performance cannot be considered as a qualified ride. Therefore, Apprentice R. Kulloo has been suspended by the Stipendiary Stewards, until satisfactorily completing an approved apprentice program.

2. Starter R. Rawa appeared before the Board, was shown the patrol films of the race and advised that in the event that the false rails available were unsuitable (as explained by him), he ought to mitigate this impact by loading the horses further out. Additionally, the Clerk of the Course, Mr. J. Sampson, will be made aware of this issue and requested to resolve such prior to the next race meeting.

- 1. Leaving the stalls, SYDS LIASON (N. Batchameah) and FREEDOM OF SPEECH (M. De Oliveira) brushed.
- 2. CARLAS MAMBO (J. Sophie) was restless and backed itself out of the gates. Thereafter, this gelding was examined by the Veterinary Surgeon, passed fit to race and reloaded.
- 3. CRAZY CHARLIE (J. Allyhosain) lost four lengths and was slow into stride.

Stewards Reports

- At the 1300m, SYDS LIASON (N. Batchameah) was momentarily steadied when awkwardly placed between CANFORD LIGHTS (B. Sooful) and FREEDOM OF SPEECH (M. De Oliveira), which drifted in whilst Jockey M. De Oliveira was adjusting his left stirrup iron. Jockey M. De Oliveira appeared before the Board and was advised to take more care when shifting ground in races, and was issued with a warning.
- 2. At the 1200m, CARLAS MAMBO (J. Sophie) shifted in and went across SYDS LIASON (N. Batchameah). Apprentice J. Sophie signed an admission of guilt for a contravention of Rule 43.2.2, in that as the rider of the horse CARLAS MAMBO, he failed to ensure that he did not cause interference to SYDS LIASON at the 1200m. A suspension from riding in races for a period of one race meeting was imposed.
- 3. CANFORD LIGHTS (B. Sooful) overraced in the early and middle stages of the race. Thereafter, this gelding was hanging in, in the straight.
- 4. CRAZY CHARLIE (J. Allyhosain) was briefly baulked for a clear run at the 300m.
- 5. FREEDOM OF SPEECH (M. De Oliveira) was hanging in, in the straight.
- 6. PARTNER IN CRIME (S. Rama) shifted out away from the whip from the 200m.

- 1. Prior to the race, Trainer S. Mahadia advised the Board that he had identified significant speed drawn on MASSIMO's inside today. Therefore, he would leave it to the Jockey to determine how much to commit regarding securing his favoured forward positioning.
- 2. Prior to the race, Trainer D. Zaki advised the Board that POP ICON will be ridden aggressively in order to lead, if possible.
- 3. The start of this race was delayed due to the near fore shoe of SEA AIR (C. Goolgar) having to be refitted at the start.

Starting Reports

- 1. THE IT FACTOR (S. Rama) was restless in the gates.
- 2. SEA AIR (C. Goolgar), WE LIGHT THE FIRE (K. Ramsamy) and BESTDAY OF MYLIFE (I. Taka) lost one length, respectively.

Stewards Reports

1. POP ICON (J. Allyhosain) overraced in the early stages.



- 2. BESTDAY OF MYLIFE (I. Taka) was ridden from the 600m, raced wide around horses and into the straight.
- 3. DUKE'S DOMAIN (M. Sonaram) took an awkward stride over the crossing at the 450m.
- 4. THE IT FACTOR (S. Rama) was baulked briefly for a clear run at approximately the 300m.
- 5. MASSIMO (M. De Oliveira) was hanging in, in the straight.
- 6. SEA AIR (C. Goolgar) raced wide around the turn and into the straight.
- 7. Jockey M. Sonaram reported that DUKE'S DOMAIN made an abnormal respiratory noise in the running. In view of this report, the Veterinary Surgeon was requested to examine.
- 8. An inquiry will be opened into the riding of SEA AIR (C. Goolgar) in the concluding stages of the race.
- 9. Jockey M. Sonaram signed an admission of guilt for a contravention of Rule 29.2.4, in that while riding the horse DUKE'S DOMAIN, he used his whip above shoulder height in the running. Accordingly, a penalty of a fine of Rs 2000 was imposed.

De Oliveira), which committed early and took the lead at the 550m. Thereafter, CAPTAIN FLYNT was hanging in, in the straight.
- 3. PRINCE ALF (M. Sonaram) was baulked for a clear run between the 400m and the 300m.
- 4. TRANSONIC (M. De OLIVEIRA) was hanging in, in the straight.
- 5. Jockey B. Sooful (CAPTAIN FLYNT) appeared before the Board, was shown the patrol films of the race and advised against the practice of using his whip down the shoulder of his horse while in the drawn position. Jockey B. Sooful was issued with a warning.

- 1. SPECIAL BLEND (S. Donohoe) showed a tendency to lay out in the straight.
- 2. At the 200m, IDITAROD TRAIL (B. Sooful) had to switch in to continue its run when awkwardly placed on heels of ALSHIBAA (J. Allyhosain), which shifted out away from the whip
- 3. Jockey B. Sooful (LUNAFACATION) appeared before the Board, was shown the patrol films of the race and and was questioned in particular with regard to his decision to correct with the left rein shortly before the finish. In this regard, Jockey B. Sooful explained that his horse had shown a tendency to hang in, in the straight, and when HUBBLE (K. Ramsamy) drifted out towards him, he was concerned that if his mount drifted in further without him correcting, it would result in interference being caused and thereby prejudicing his horse. The Board noted the explanations of Jockey B. Sooful.
- 4. Jockey B. Sooful signed an admission of guilt for a contravention of Rule 29.2.15, in that he used his whip down the shoulder of LUNAFACATION, whilst in the drawn position. Accordingly, a penalty of a fine of Rs 2,000 was imposed on him.
