Starting Reports

- 1. ROMANUS (A. Paya) jumped awkwardly.
- 2. MOON JUMPER (N. Batchameah) fly jumped.

Stewards Reports

- 1. MOON JUMPER (N. Batchameah) raced wide in the early stages. Thereafter, this gelding raced wide around the turn and into the straight.
- 2. The saddle of DAYLA VISTA (T. Ladouceur) slipped forward in the running. This was confirmed by the Veterinary Surgeon. As a consequence of this incident, Apprentice T. Ladouceur was unable to fully assist this gelding in the running, and this performance could not be considered a satisfactory qualifying ride.
- 3. DUKE OF ABERCORN (K. Ramsamy) hung out in the straight and carried out ROMANUS (A. Paya).
- 4. Apprentice N. Batchameah, reported that MOON JUMPER did not stride out freely in the running. In view of this report, the Veterinary Surgeon was requested to examine.
- 5. Assistant Trainer J. Awotar and Apprentice T. Ladouceur appeared before the Board and were questioned regarding the instructions on DAYLA VISTA (T. Ladouceur). In this regard, Assistant Trainer J. Awotar explained that when assessing the race, he was of the view that DAYLA VISTA could lead easily, particularly with the addition of the blinkers for the first time. Accordingly, he instructed Apprentice T. Ladouceur to jump, not push this horse and allow it to use his natural early speed. He further explained that he instructed Apprentice T. Ladouceur that if another horse committed for the lead aggressively, he was to take cover and attempt to settle this gelding.

Apprentice T. Ladouceur explained that after seeing Jockey K. Ramsamy (DUKE OF ABERCORN) ride as aggressively for the lead as he did, he elected to not take him on and risk DAYLA VISTA becoming fierce throughout. The Board noted the explanations of both Assistant Trainer J. Awotar and Apprentice T. Ladouceur.



- 6. Apprentice A. Paya (ROMANUS) signed an admission of guilt in respect of a contravention of Rule 43.2.4, in that he made an excessive celebratory gesture prior to the finish of the race. Accordingly, a penalty of a fine of Rs 5,000 was imposed.
- 7. Jockey K. Ramsamy signed an admission of guilt for a contravention of Rule 29.2.5, in that he struck the horse DUKE OF ABERCORN with his whip more than once on consecutive strides in the running. Accordingly, a penalty of a fine of Rs 3,500 was imposed.

1. ITDAWNEDONME (J. Allyhosain) began awkwardly.

Stewards Reports

 Leaving the 900m, KALGOORLIE (M. De Oliveira) was carried out by VIKING TRAIL (K. Ramsamy), which rolled out.



- 2. GIGGIN (B. Bhaugeerothee) hung in, in the straight.
- 3. KALGOORLIE (M. De Oliveira) raced wide into the straight.
- 4. Apprentice N. Batchameah signed an admission of guilt for a contravention of Rule 29.2.15, in that he used his whip down the shoulder of EAGLES VISION, whilst in the drawn position. Accordingly, a penalty of a fine of Rs 3,500 was imposed on him.
- 5. Trainer P. Nagadoo and Apprentice N. Batchameah (EAGLES VISION) appeared before the Board and were questioned regarding the lack of intent shown on EAGLES VISION at the start of the race. In this regard, Apprentice N. Batchameah explained that he was instructed to ride EAGLES VISION where it was comfortable in the race. He further explained that ideally, he would have liked him to be placed in a more forward position than where he found himself. However, after jumping on only even terms, he did not want to commit his horse too early and instead elected to take cover at the rear of the field, which was aligned with the pattern of racing in EAGLES VISION's best run of the season (13 May 2023). He further explained that he had intended to make a move from the 700m, but he did not have sufficient room to do so. Trainer P. Nagadoo explained that he expected ITDAWNEDONME (J. Allyhosain) to press the pace with GIGGIN (B. Bhaugeerothee) and therefore wanted EAGLES VISION to run behind this speed. However, after the jump, he accepted that it was not possible for EAGLES VISION to move forward without risking being trapped wide. Consequently, he was happy that Apprentice N. Batchameah restrained and took cover. The Board noted the explanations of both Trainer P. Nagadoo and Apprentice N. Batchameah.

Starting Reports

- 1. PETE THE PILOT (M. Sonaram) reared over in the stalls. Subsequently, this horse was removed from the stalls, examined by the Veterinary Surgeon and withdrawn.
- 2. CARINO BELLO (C. Goolgar) and HIDDEN IDENTITY (S. Donohoe) lost one length and brushed.
- 3. SMUTS (S. Rama) and SONNENSTRAHL (K. Ramsamy) bumped.

Stewards Reports

1. In view of the Starting Report, the starting stall certificate for PETE THE PILOT (M. Sonaram) has been withdrawn. This gelding has been suspended from racing for seven days until proving tractable in the starting stalls and completing a barrier trial to the satisfaction of the Stipendiary Stewards.

- 2. SUPERIOR FORCE (M. De Oliveira) and GOOD BUDDY (R. Perez) raced wide in the early stages.
- 3. At the 700m, GANG LEADER (J. Allyhosain) was carried out by SUPERIOR FORCE (M. De Oliveira), which shifted out in order to obtain clear running. Thereafter, GANG LEADER (J. Allyhosain) was shifted in to obtain the position on the rail behind the leader.

- 7. Trainer S. Narang signed an admission of guilt for a contravention of Rule 86.1, in that he failed to ensure that the registered colours for GOOD BUDDY on the day was available for racing. Accordingly, a penalty of a fine of Rs 2,000 was imposed.

- 1. Prior to the commencement of this race, the instructions for all riders were taken by the Stipendiary Stewards. In this regard, each of the instructions matched the racing pattern of the horses.
- 2. The start of this race was delayed due to ONE DAY OR DAY ONE (N. Batchameah) being reluctant proceeding to the start and having to be led by a handler.

Starting Reports

- 1. ONE DAY OR DAY ONE (N. Batchameah) jumped awkwardly and lost one length.
- 2. NOBLE TRIP (M. Sonaram) jumped awkwardly and lost two lengths.



3. SAND PATH (I. Taka) and JAMES PETER (K. Ramsamy) came together and brushed.

Stewards Reports

- 1. JET STREAM (S. Rama) was restrained from a wide draw into a rearward position.
- 2. From a wide draw, CAPTAIN COLA (R. Perez) was ridden aggressively in order to find the lead at the 1100m.
- 3. MOROCCAN RETREAT (S. Donohoe) raced wide in the early stages.
- 4. BON BOYAGE (M. De Oliveira) raced wide from the 450m. Thereafter, Jockey M. De Oliveira did not persevere with his riding of this gelding in the straight, and subsequently reported that this horse choked up in the running.
- 5. ONE DAY OR DAY ONE (N. Batchameah) and STAGEWORLD (J. Bardottier) hung in, in the straight.
- 6. At the 200m, NOBLE TRIP (M. Sonaram) switched in to continue its run.
- 7. SAND PATH (I. Taka) shifted out away from the whip at the 150m.
- 8. TICKET TO CAIRO (I. Chisty) shifted in away from the whip in the concluding stages.
- 9. Jockeys I. Chisty (TICKET TO CAIRO), K. Ramsamy (JAMES PETER) and Apprentice M. Sonaram (NOBLE TRIP) reported that their respective horses did not stride out freely in the running. In view of this report the Veterinary Surgeon was requested to examine. In view of the Veterinary Surgeon's report pertaining to the aforementioned horses, Trainers A. Rahmathulla, Y. Emamdee and S. Hurchund will be requested to report back on the condition of their respective horses on return to the stables.
- 10. The time for this race was not taken correctly. This issue will be addressed with the PTP. In this regard, no time was taken for horses outside the first four placings and one timer did not time the race. In terms of the report, the PTP will be reminded that it employs two persons to time the race, this is not a responsibility of the Judge, who must focus on the running of the race and necessary corrective measures must be put in place in writing prior to the next race meeting.

1. Race 1 - THE WE LOVE MAHEBOURG VOLUNTEER CUP - [0 - 20] - 1365m

Trainer K. Ramanah signed an admission of guilt in respect of a contravention of Rule 81.1.36, in that he communicated with two Jockeys outside the Jockeys' Room after being instructed not to do so. Accordingly, a penalty of a fine of Rs 10,000 was imposed.

2. The shoes of the handler were inspected by the Stipes today. In this regard, despite numerous warnings to PTP, there were many handlers who were still non-compliant with the basic requirements of having proper safety shoes. This matter will be addressed in a report to the PTP.

3. RACE MEETING 17: Race 2 - BOOK A TABLE AT PTP CUP - [0 - 15] - 990m

"At the 900m, SUPREME ELEVATION (R. Kulloo) shifted out when awkwardly placed in respect of the running rail. In reaction to this movement, LE QUARTIER (I. Taka) was momentarily inconvenienced, took a hold, shifted out and carried out CHESTNUT COVE (J. Allyhosain). Additionally, the saddle of SUPREME ELEVATION slipped forward in the running. This was confirmed by the Stipendiary Stewards during the viewing of the footage.

In light of this being another ride with a delayed correction from Apprentice R. Kulloo, the Stipendiary Stewards are in the opinion that his performance cannot be considered as a qualified ride. Therefore, Apprentice R. Kulloo has been suspended by the Stipendiary Stewards, until satisfactorily completing an approved apprentice program."

In light of the above report, on 25 July 2023, the Stipendiary Stewards observed the activities of Apprentice Kulloo whilst riding work at the Petit Gamin Trainer Centre. After such observation and discussion with his Trainer, Mr. D. Zaki, the Stipendiary Stewards were satisfied that Apprentice Kulloo was able to feed, maintain and saddle a horse. Additionally, Apprentice Kulloo completed two gallops to the satisfaction of the Stipendiary Stewards. Consequently, the Stipendiary Stewards were satisfied that Apprentice Kulloo was able to demonstrate the necessary 'broader based'



understanding of the racehorse which Apprentices are required by the HRD to have. Accordingly, the suspension on Apprentice Kulloo was lifted with immediate effect.
