- 3. At the 450m, SIEGE RAM (R. Joorawon) was carried out by STRAIGHT (I. Chisty) which shifted out to continue its run.
- 4. Jockey S. Donohoe, rider of DESERT ILLUSION, reported that his horse was not striding out and he suspected that the horse was lame. The Veterinary Surgeon was requested to examine.
- 5. Jockey M. De Oliveira, rider of WALKING ON WINGS was questioned regarding the poor performance of his horse, a last time winner. He stated that his horse was not striding out well in the initial stages and had a tendency to lug in, in most parts of the race, whereby he could not get a proper position and ride his horse out to his best efforts. The Trainer, Mr. S. Mahadia, stated that the horse was galloping with its head high and was running a bit green and in his opinion, the horse needs a tongue tie in its next run. He also stated that he was very disappointed with the horse's run.

 Trainer S. Hurchund signed an admission of guilt for a contravention of the Guidelines for Declaration in that after having nominated WILLIAMSHAKESPEARE for race meeting 18, he failed to declare this horse. Accordingly, a penalty of a fine of Rs 5, 000 was imposed.

# 2. <u>22<sup>nd</sup> July 2023 – Race Meeting 18</u>

The shoes of the handler were inspected by the Stipes today. In this regard, despite numerous warnings to PTP, there were many handlers who were still non-compliant with the basic requirements of having proper safety shoes. This matter will be addressed in a report to the PTP.

Following the above report, at today's race meeting, all Handlers shoes were checked and it was confirmed that the staff had been equipped with the necessary safety shoes.

# 3. <u>22<sup>nd</sup> July 2023 – Race Meeting 18 - Race 8 - 16:15 - The Royal Life Saving Society</u> (Mauritius) Cup

The time for this race was not taken correctly. This issue will be addressed with the PTP. In this regard, no time was taken for horses outside the first four placings and one timer did not time the race. In terms of the report, the PTP will be reminded that it employs two persons to time the race, this is not a responsibility of the Judge, who must focus on the running of the race and necessary corrective measures must be put in place in writing prior to the next race meeting.

Following the above report, a meeting was held between the HRD, the CEO of the PTP and the PTP time keepers. The issues regarding the time were addressed at this meeting and all matters were resolved. At today's racing, all time recordings were taken correctly.
