7. Jockey R. Joorawon signed an admission of guilt for a contravention of Rule 29.2.10, in that he struck the horse CHESTNUT COVE with the whip whilst dismounted. Accordingly, a penalty of a fine of Rs 15,000 was imposed.

Donohoe anticipated that ILLICIT KISS would continue its inward motion to the rail. Thereafter,

at the 1100m, ILLICIT KISS, which raced fiercely in the early and middle stages, was directed into a three deep position to race around the field and to the position outside the leader at the 700m.

2. At the 400m, GLOBAL GLORY (M. De Oliveira) was switched from the inside into a three deep running line. Thereafter, this gelding raced wide around the turn and into the straight.
3. In the concluding stages, ILLICIT KISS (R. Perez) was carried out by INSTINCTIVE POWER (J. Allyhosain), which shifted out away from the whip.
4. In view of the performance of BRILLIANT DISGUISE (S. Donohoe), the Veterinary Surgeon was requested to examine.

MASSIMO was subsequently restrained, returned to the start, examined by the Veterinary Surgeon and passed fit to race. However, stall gate 2 was unable to be repaired prior to the race jumping, therefore, the Stipendiary Stewards granted permission for the stall gates inside of this damaged stall gate to be used.
2. LICKERIO (S. Rama) raced wide in the early stages.
3. Leaving the 1300m, TRIP TO THE SKY (R. Joorawon) had to ease when awkwardly placed on the inside of TORO BRAVO (D. Bheekary), which shifted in. An inquiry will be opened into this incident.
4. LICKERIO (S. Rama) was hanging in, in the straight.
5. MASSIMO (M. De Oliveira) shifted in away from the whip in the concluding stages.
6. Jockey R. Perez (CULTURE TRIP) appeared before the Board and was questioned regarding his decision to allow BATTLE OF ALESIA (S. Donohoe) to shift in, in front of CULTURE TRIP at the 1200m. In this regard, Jockey R. Perez explained that CULTURE TRIP had a tendency to get fierce in the running of his races. Consequently, after getting his mount settled, he did not want to risk pushing up on the inside of BATTLE OF ALESIA and risk CULTURE TRIP not settling for the remainder of the race. The Board noted the explanation of Jockey R. Perez.
7. An inquiry has been opened into R. Perez's (CULTURE TRIP) whip use in this race.
8. Apprentice K. Ramsamy, reported that ETCHED IN BLUE did not stride out freely in the running. In view of this report, the Veterinary Surgeon was requested to examine.

SUPPLEMENTARY REPORT

RACE MEETING 18, HELD ON 22ND JULY 2023 - PEOPLE'S TURF PLC

On 23rd August 2023, the Inquiry Board comprising of Stipendiary Stewards concluded an inquiry at the Office of the Horse Racing Division into the positive finding of a prohibited substance, DEXAMETHASONE, in the blood sample taken on 20th July 2023 from AFTER THE ORDER, a declared runner in Race 01 under the care of Trainer C Ramdin at the Champ De Mars Racecourse.

DEXAMETHASONE falls in Class 4 in the List of Prohibited Substances published by the Horse Racing Division.

Mr. C Ramdin was interviewed in this regard and pleaded not guilty to the charge of contravening Rule 69.1.2, however the Board found him guilty, in that, he, Mr. Ramdin, as the Trainer of the horse AFTER THE ORDER, was guilty of an offence as the sample taken from this horse at any time within 72 hours preceding the Day of the Race in which this horse was due to run disclosed upon analysis the presence of a Prohibited substance.

Consequently, Mr. C Ramdin, as per the Guidelines published in this regard, was fined a sum of Rs.40,000 and he was advised of his right to Appeal.
