## General

1. Prior to the commencement of this race, the instructions for all riders were taken in the Boardroom. In this regard, each of the instructions matched the racing pattern of the horses, except for POP ICON (J. Bardottier) and MASSIMO (C. Goolgar). In this regard, Trainer D. Zaki advised that as he anticipated pace in the race, coupled with an unfavorable draw, therefore instead of cutting pace, he would like POP ICON to be slotted behind the front runners.

Further, Trainer S. Mahadia advised that he expected pace in this race and therefore, would like MASSIMO to be close with the pace, however, if the opportunity arises to lead, he may lead. These changes of tactics were disseminated to the public.

## Starting Reports

1. POP ICON (J. Bardottier) hesitated at the start, reared up and brushed the gates, losing ground.
2. MASSIMO (C Goolgar) jumped awkwardly outwards.
3. MOROCCAN RETREAT (K. Ramsamy) was slow by two lengths.

## Stewards Reports

1. Leaving the 1300 m , SWAGGER JAGGER (M. De Oliveira) shifted ground inwards and took the running of THE EIGHTH LORD (M. Sonaram) which was eased, POP ICON (J Bardottier), who was following, had to be eased, lost ground. Jockey M. De Oliveira signed an admission of guilt for a contravention of Rule 43.2.2 in that as the rider of the horse SWAGGER JAGGER, he failed to ensure that he did not cause interference to THE EIGHTH LORD at the 1300 m . A suspension from riding in races for one ( 01 ) Race Meeting was imposed.
2. MASSIMO (C Goolgar) and POP ICON (J Bardottier) were hanging in, in the straight.
3. CLOUD SEEDER (S. Rama) began giving ground to the field from the 500 m and trailed eventually.
4. During the running of this Race, near the 800 m , a wire could be seen going across the Sand Track, on to the running Rail and on the Racing Grass Track. The HRO was asked
to submit a Report on the incident, and advised that it was a Mauritius Broadcasting Corporation wire, which accidently became disengaged from its clip and the matter was promptly resolved.
