#### **Starting Reports**

- 1. CRACKON (M. Sonaram) jumped awkwardly and was eased off the heels of ITALIAN WAY (I Chisty).
- 2. DAYLA VISTA (S. Bhundoo) jumped awkwardly and brushed with CRACKON (M. Sonaram).
- 3. ITALIAN WAY (I. Chisty) jumped awkwardly outwards and went across the running line of CRACKON (M Sonaram) and DAYLA VISTA (S Bhundoo).

### **Stewards Reports**

- 1. Jockey S. Bhundoo (DAYLA VISTA) appeared before the Board and was shown the patrol films of the race, in that, leaving the 1200m, he rode his horse in a restricted manner, thereby easing the pace of the race which resulted in ROMANUS (R. Joorawon) being eased and shifted in, due to which CRACKON (M. Sonaram) was eased.
  - He was found in contravention of Rule 43.2.9, in that, he failed to ensure that he did not excessively slow, reduce or check the speed of his horse, thereby causing interference to ROMANUS (R. Joorawon) and CRACKON (M Sonaram). A suspension from riding in races for a period of one race meeting was imposed.
- 2. Near the 1100m, ITALIAN WAY (I. Chisty) brushed the rail and became unbalanced.
- 3. DAYLA VISTA (S. Bhundoo) which was pulling in the race, was restrained on a few occasions in the running.
- 4. Near the 800m, Jockey R. Joorawon (ROMANUS) elected to make his move from the outside of DAYLA VISTA (S. Bhundoo) in order to progress in the race.
- 5. ROMANUS (R. Joorawon) came through awkwardly from the crossing at the 450m.
- 6. When afforded an opportunity to explain his ride on ITALIAN WAY, Jockey I Chisty advised that his intention was to relax his horse after the start and allow him to gallop on its own from a rear position, in a similar manner when this horse had won earlier. This time the horse had jumped well, contrary to his expectations and then brushed the rails near the 1100m, losing ground and in his view the pace also picked up, however, he wanted to give his horse a chance and he allowed his horse to gallop at its speed. Further, his horse was in a good position around the 700m. The explanation was noted.

### **Stewards Reports**

1. A review of the start of the race was held. The reason being that PADRE PIO (I. Taka) drawn in stall 3, may have been impeded at the start, with a Handler holding the horse in its stall as the gates opened.

In this regard the Starter, Mr. R. Rawa, and Apprentice I. Taka appeared before the Board. Having taken their evidence in the matter, and having viewed the patrol films of the incident from different angles, the Stipendiary Stewards assessed that the start of this horse was impeded by the Handler holding the horse. In view of this assessment, the Board declared PADRE PIO a non-runner under the Rules.

All monies invested on PADRE PIO were ordered to be refunded. Fixed odds winning bets were deducted by 45 cents per rupee on the face value of the ticket.

2. PADRE PIO (I. Taka) overraced in the early stages.

# 1. RACE MEETING 39 HELD ON 18<sup>TH</sup> NOVEMBER 2023 – PEOPLES TURF PLC RACE 09 – LA JOURNEE MONDIALE DES VICTIMES DES ACCIDENTS DE LA ROUTE CUP

In view of WELL CONNECTED being assisted out of the Starting Gates after the horse refused to jump, the Starter had advised that, in his opinion, the field had gone far away and in order to timeously move the starting gates off the race track, WELL CONNECTED was assisted to jump out of its stall by the Handlers.

## 2. RACE MEETING 36 HELD ON 04<sup>TH</sup> NOVEMBER 2023 – PEOPLES TURF PLC RACE 07 – LES RETRAITES DE LA FLORA SENIOR CITIZEN CUP

An Inquiry held at the Offices of the HRD on 24 November 2023, Jockey I. Chisty (ROYAL ITALIAN) was charged with a contravention of Rule 43.2.1, in that, he had failed to take all reasonable and permissible measures throughout the running of the race in order to ensure that his horse, ROYAL ITALIAN, is given a full opportunity to win or obtain the best possible placing in that Race.

Jockey I. Chisty pleaded not guilty to the charge; however, he was found guilty as charged. After considering the evidence in this matter, the Inquiry Board imposed a penalty of a suspension from riding in races for a period covering 10 Race Meetings.

Jockey I. Chisty has the right of appeal against the charge as well as the penalty imposed.

### 3. RACE MEETING 40 HELD ON 25<sup>TH</sup> NOVEMBER 2023 – PEOPLES TURF PLC

Trainer Y Emamdee signed an admission of guilt with regard to contravention of Declarations Guidelines, in that, he failed to declare his horses for the Race Meeting 40 scheduled for 25<sup>th</sup> November 2023.

Accordingly, a penalty of a fine of Rs. 5,000 was imposed on him.
