Race 1, Jockey O Sola was replaced by Apprentice A Roy on TIGER'S BOND.

Race 2, Jockey O Sola was replaced by Apprentice A Roy on CAROLINA REAPER.

Race 6, Jockey R Joorawon was replaced by Jockey N Marday on THE DAZZLER.

Stewards' Reports

Acting on a report from the Course Medical Doctor that Jockey O Sola, a declared rider for the day, had provided an abnormal breath sample which was an alleged contravention of Rule 94 of the Rules of Racing and was stood down from all his engagements for the day.

An inquiry has been opened into the matter.

At the start, NORTHERN REBEL (N Marday) jumped outwards awkwardly.

Soon after the start, MASTEROFALLISURVEY (I Taka) ducked out whereby the rider was unbalanced momentarily and then took the running of TIGER'S BOND (A Roy) which was steadied.

MASTEROFALLISURVEY (I Taka) was caught wide in the middle stages.

After the race, a review was held into the running of the race in the home stretch owing to an alleged interference passing 100m as DAYLA VISTA, the declared Winner, shifted ground inwards and made contact with WILDE WORLD, placed 2nd by the Judge. Whilst deciding, the Stewards were satisfied that the interference was close to the winning post and after the interference WILDE WORLD did not appear to gain ground on DAYLA VISTA and that Jockey RK Chumun (WILDE WORLD) had not stopped riding at any stage. Therefore, the Stewards could not be satisfied that but for the interference WILDE WORLD would have finished ahead of DAYLA VISTA. Hence, the correct weight was declared on the Placings as declared by the Judge.

An inquiry was held on 14th Sep 2022 at the Office of the Horse Racing Division. The Stewards interviewed Jockey O Sola in respect of his abnormal breath sample provided by him before the races on 11th Sep 2022, when he was declared to ride TIGER'S BOND in the first race of



Race Meeting 20 at the Champ De Mars Racecourse, that gave a reading of 20 micrograms of ethanol per 100 ml of breath. Jockey O Sola pleaded guilty to the charge in that he was found in contravention of Rule 92 (a) of Rules of Racing, read in conjunction with Rule 94 (a) of the Rules of Racing.

After having considered the submissions of Jockey O Sola and his mitigating circumstances, the Stewards imposed a penalty of suspension from riding in races for a period of one month, covering a period of 06 Race Meetings i.e., from 18th Sep 2022 up to the midnight of 17th Oct 2022. Jockey O Sola was advised of his right to Appeal.

ZIGI ZAGI ZUGI (A Roy) was scratched at 13h41. All monies invested on ZIGI ZAGI ZUGI were ordered to be refunded. Fixed odds winning bets were deducted by 5 cents per rupee on the face value of the ticket.

COUP FOR LUTE (G D Aucharuz) ran erratic near 200m briefly.

CAPTAIN MIKE (N Teeha) shifted out in the concluding stages while ridden under the use of the whip.

Jockey A L Da Silva (CONSUL OF WAR) carried 1kg overweight and weighed out at 55kg.

At the start, SPRING MAN (M Sonaram) was slow and lost one length. THE DAZZLER (N Marday) began awkwardly.

Shortly after the start, ABSOLUTIST (J Da Silva) ducked out and tightened ALSHIBAA (B Fayd'herbe) on to CRANK IT UP (D Schwarz).

Approaching the 200m, ABSOLUTIST (J Da Silva) shifted out and took the running of ALSHIBAA (B Fayd'herbe) which had to be steadied momentarily and was switched to the inside.

An inquiry has been opened into the use of blinkers on ABSOLUTIST.

ENIGMA CODE was scratched on Veterinary advice on 10th September 2022 at 12hr05. All bets on ENIGMA CODE were ordered to be refunded and betting to be reopened.

At the start, TRAVELIN MAN (N Teeha) began awkwardly.

Soon after the start, GIRATORIO (D Schwarz) jumped outwards and as this horse was being corrected, shifted in made contact with OXFORD BLUE (GD Aucharuz). Soon after, VOLATILE



ENERGY (A Roy) shifted in and went across GIRATORIO causing GIRATORIO to shifted in on to OXFORD BLUE who made contact with UNBELIEVABLE LAD and ricocheted back on to GIRATORIO and was awkwardly placed behind the heels of TRAVELIN MAN and steadied.

GIRATORIO (D Schwarz) travelled wide while coming into the home turn and in the straight.

Jockey D Schwarz (GIRATORIO) has been reprimanded for using his whip on consecutive strides in the running before the 100m.

Jockey N Teeha (TRAVELIN MAN) was reprimanded for using the whip after the winning post.

An Inquiry has been opened into the whip use of Jockey GD Aucharuz (DESERT ILLUSION) in the straight before the 100m.

An inquiry has been opened into the use of blinkers on CRIMSON GOD.

1. Pre-race blood specimens were taken from all starters which were reported to be negative.
2. In all races, all the riders were weighed in.
3. All the winners were selected for the taking of specimens for analysis.



4. All riders were breathalysed and cleared to ride, except for Jockey O Sola whose sample was found abnormal.
