Race 5, Jockey N Teeha was replaced by Jockey J Allyhosain on CASTLE OF GLASS.

Race 7, Jockey G D Aucharuz was replaced by Jockey B Jacobson on MASTER OF ILLUSION.

The bridle on EXECUTIVE DECISION (N Marday) was refitted behind the gates.

Near 1200m, CHESTNUT COVE (I Taka) brushed the rails.

Near 1100m, INSTINCTIVE POWER (GD Aucharuz) raced keen.

While straightening for home, STRAIGHT (N S Batchameah) and UNBELIEVABLE LAD (S Rama) brushed.

Near the 100m, STRAIGHT (N S Batchameah) lugged in and UNBELIEVABLE LAD (S Rama) was carried in which further caused INSTINCTIVE POWER (G D Aucharuz) to shift in. Trainer P Nagadoo has been advised to rectify this trait of the horse.

CHESTNUT COVE (I Taka) travelled wide from 400m and in the straight.

PERFECT PURSUIT (M Sonaram) threw its head up between 1200m and 900m.

After being stalled, AFTER THE ORDER (G D Aucharuz) was restless.



Horse Racing Division

At the start, VOLATILE ENERGY (I Taka) stumbled.
ZUM ZUM (N Teeha) brushed the gate on jump out.
TRACKBUSTER (N Marday) jumped awkwardly.
OVERDOSE (B Deenath) was slowly away by one length.

TRACKBUSTER (N Marday) over raced in the early stages of the race and had to be steadied.

Near 1100m, AFTER THE ORDER (GD Aucharuz) was eased off the heels of HIDDEN IDENTITY (L Goomany) who had shifted inwards while being settled.

OVERDOSE (B Deenath) raced wide in the back stretch briefly and then near the 450m crossing.

Jockey B Fayd'herbe (SHESH BESH) reported that his horse ran green and was flat in the running. The Stewards interviewed the Jockey, who explained that he felt that the horse was finding its feet in the running and that he did not find him as comfortable as the other horses and that's what he meant by his horse being 'green'. He added that the last run of the horse was on the 10th Sep 2022 and that the time gap between the two races was probably short. He further advised that the horse did not respond to his use of whip. The explanation was noted.

Jockey B Jacobson (PIN DROP) was found in contravention of rule 147(6)(a)(i), in that, prior to the 100m mark, he used his whip in consecutive strides and, as such, a reprimand has been issued to him.

ZUM ZUM (N Teeha) lugged-in in the straight.

There was a Double Declaration in respect of App I Taka who was declared to ride HEART OF DARKNESS and FASSI. After an inquiry in the matter with Assistant Trainer Y Perdrau, who



represented Trainer A Perdrau, Trainer A Perdrau was fined Rs 2000 for being responsible for the Double Declaration of the Rider under Rule 112D of the Rules of Racing. He was apprised of his right of appeal.

At the start, PROFICIENT (J Allyhosain) jumped awkwardly and jostled with NIGHTINGALE LANE (N Marday), who itself had jumped out awkwardly, and then went onto DIGITAL FORTRESS (N S Batchameah), who while regaining its balance shifted in and inconvenienced NIGHTINGALE LANE (N Marday).

At the start, ENIGMA CODE (N Teeha) brushed the gates.

Jockey R Joorawon (GONTRAVLIN) used his whip in consecutives strides in the running prior to the 100m and therefore, he was found in contravention of the Rule 147 (6)(a)(i) of the Rules of Racing. Consequently, a reprimand has been issued to him.

In the concluding stages, FASSI (A Roy) shifted in while ridden under the whip and brushed with AFRICAN ROCK (M Sonaram).

Jockey N Teeha (ENIGMA CODE) reported to the Medical Doctor as he had injured his 5th toe and was declared unfit to ride for his remaining engagements. Jockey N Teeha will be required to submit a Certificate of fitness.

At the start, JACK TARR (L Goomany) brushed the gates.

At the start, MOROCCAN RETREAT (G D Aucharuz) was restless in the stalls and had jumped awkwardly inwards and brushed with SAN ANDREAS (A Andrews). And then MOROCCAN RETREAT was eased off the heels of JACK TARR (L Goomany).



At the start, EDGE OF THE SUN (J Da Silva) jumped awkwardly outwards and took the running of JACALAC (B Fayd'herbe) who was then steadied.

Jockey A L Da Silva (MAURITIUS) was interviewed in respect of the movement of his horse in the home straight, wherein his horse first shifted ground inwards and took the line of running of JACK TARR (L Goomany) and then shifted away from the rails. After interviewing Jockey A L De Silva, he has been cautioned for failing to keep a straight course.

Subsequently, Jockey L Goomany (JACK TARR) was also interviewed and he confirmed that he felt that his horse was intimidated by the shifting of MAURITIUS (A L Da Silva), though he had room to ride out and he had not stopped riding.

Jockey GD Auchuraz (MOROCCAN RETREAT) was examined by the Medical Doctor post-race with an injury on the ankle of his right foot. The Jockey was conveyed to the City Clinic for further examination. The Jockey was declared unfit to ride for the remaining engagements for the day. He is required to produce a Medical Clearance before riding again.

At the start, MEMPHIS MAFIA (M Sonaram) and SENOR'S GUEST (S Rama) were slow. CASTLE OF GLASS (J Allyhosain) and CLOUD SEEDER (J Da Silva) brushed the gates.

Shortly after the start, BESTDAY OF MYLIFE (M P De Oliveira) was steadied and eased off the heels of FREE TO WIN (AL Da Silva) as CLOUD SEEDER (J Da Silva) shifted ground inwards when JAMES PETER (B Sooful) shifted inwards.

Leaving the 1300m, MEMPHIS MAFIA (M Sonaram) was tightened for room and steadied while racing on the inside of BESTDAY OF MYLIFE (MP De Oliviera).

Near 1100m, JAMES PETER (B Sooful) was inclined to drift out and brought on an even keel.



MEMPHIS MAFIA (M Sonaram) was eased off the heels of JAMES PETER (B Sooful) in the concluding stages of the race.

SENIOR'S GUEST (S Rama) travelled wide for most part of the race.

TRIP TO THE SKY (A Andrews) jumped out awkwardly, brushing the gates and was then eased off heels of NINOTTO (M Sonaram) and was taken behind runners.

Apprentice M Sonaram (NINOTTO) was found in contravention of rule 147(6)(a)(i) in that prior to the 100m mark, he used his whip in consecutive strides and, as such, a reprimand has been issued to him.

Soon after the start, SEATTLE KID (MP De Oliveira) jumped awkwardly inwards and jostled with ACTION PACKED (B Fayd'herbe) who was tightened on to MASTER OF ILLUSSION (B Jacobson) and was squeezed out.

BATTLE OF ALESIA (N S Batchameah) travelled wide during the race.

CULTURE TRIP (B Sooful) was denied a clear run in the final stages, while racing behind SEATTLE KID (M P De Oliveira) and MASTER OF ILLUSSION (B Jacobson).

At the start, BOLLINGER (B Fayd'herbe) brushed the gates. VIKING TRAIL (A Andrews) and PRINCE ALF (A L Da Silva) were slowly away.

Approaching 1300m, SPIRITUAL WIND (J De Souza) was tightened for room while racing on the inside of WINTER GUARD (J Da Silva) and lost position.

Leaving 1300m, GOOD BUDDY (C Maujean) jumped over the crossing. Shortly after, WINTER GUARD (J Da Silva) drifted out and carried SPIRITUAL WIND (J De Souza) along with it.

WINTER GUARD (J Da Silva) brushed the rails at around the 900m.

SLIGHTLY SCOTTISH was scratched on Veterinary advice on 25th September 2022 at 11hr33. All bets on SLIGHTLY SCOTTISH were ordered to be refunded and betting to be reopened.

Apprentice I Taka (BELLS APOSTLE) claimed only 3.0kg out of his 4.0kg allowance and weighed out at 54.5kg.

JET PATH (D Schwarz) lashed at the gates and then jumped awkwardly outwards.

At the start, MISTY ROLLER (S Rama) began awkwardly.

MAJESTIC MOON (N S Batchameah) and THE GYPSY KING (M Sonaram) were slowly away. BELLS APOSTLE (I Taka) began awkwardly.



ARTAX (J Da Silva) jumped awkwardly outwards and took the running of THE GYPSY KING (M Sonaram) who was steadied.

Soon after the start, JET PATH (D Schwarz) and BYPASS (K Teetan) brushed.

Shortly after, BYPASS (K Teetan) brushed with MASTEROFALLISURVEY (J Allyhosain).

Approaching the 1300m, THE GYPSY KING (M Sonaram) was steadied off the heels of BYPASS (Koyal Teetan) as the latter shifted ground inwards. THE GYPSY KING was steadied again near the 1100m and near 900m.

In the concluding stages of the race, JET PATH (D Schwarz) was carried outwards as BELLS APOSTLE (I Taka) shifted ground while ridden under the whip.

MASTEROFALLISURVEY (J Allyhosain) hung out briefly in the straight.

After the race, Jockey K Teetan (BYPASS) fell from his horse. He is required to submit a Medical Clearance.

MAJESTIC MOON – Lameness off fore.

SLIGHTLY SCOTTISH – Injury off fore fetlock -lame.

GENERAL:

The Clerk of the Scales reported that Jockey K Teetan who was nominated to ride at this Race Meeting and had entered the Jockey's Room and had left the Jockey's Room on a few occasions without fulfilling the requirements in terms of the Rules.

In view of the above, Jockey K Teetan has been reprimanded and informed that on repetition of a similar conduct, severe disciplinary action may be taken against him.

Other comments/Explanations:

1. Pre-race blood specimens were taken from all starters which were reported to be negative.
2. In all races, all the riders were weighed in.
3. All the winners were selected for the taking of specimens for analysis.
4. All riders were breathalysed and cleared to ride.
