### JOCKEY CHANGES

Race 5, Jockey J Allyhosain was replaced by Jockey J De Souza on HUBBLE.

Race 6, Jockey J Allyhosain was replaced by Jockey A L Da Silva on CARTEL BOSS.

Race 8, Jockey J Allyhosain was replaced by Jockey R Joorawon on THOMAS HENRY.

#### **Stewards' Reports**

Jockey S Rama (THE RIGHT STUFF) carried 0.5kg over the carded weight and weighed out at 52.5kg.

Trainer V. Ruhee apprised the Stewards of the change of tactic on ZUM ZUM (M Sonaram) whereby he instructed the Jockey to "lead" this time.

Near the 1200m, MOON JUMPER (S Bussunt) who was travelling wide was eased and shifted-in so as to place his horse behind runners causing BONJOUR BABY (J De Souza) to ease.

Soon on entering the home straight, ZUM ZUM (M Sonaram) went across CHARLIE SQUADRON (J Allyhosain) who was switched out in the running.

An inquiry has been opened into the running of this race.

#### **Stewards' Reports**

At the start, JOHN HANCOCK (S Bussunt) jumped awkwardly outwards and brushed with NIKHILS INN (J De Souza).

At the start, CHOSEN WAY (J Allyhosain) was slow by one length.

Near the 1400m, FREE TO WIN (A L Da Silva) was squeezed out while racing in a restricted room between NIKHILS INN (J De Souza) and CHARLESTON HERO (D Schwarz) and was eased.



Near 300m, HIGH KEY (A Roy) was eased off the heels of JOHN HANCOCK (S Bussunt).

HIGH KEY (A Roy) hung in, in the straight. Trainer S Narang has been advised to correct this trait of the horse.

**Stewards' Reports**

Near the 1900m, MOSCHINO (R Joorawon) was eased off the heels of IMPERIAL RAGE (J Allyhosain).

Between 900m and 800m, TAKING SILK (K Ramsamy) was carried out by LEMON DROP SHOT (N Teeha) which rolled out after the turn. As a consequence of this incident, IMPERIAL RAGE (J Allyhosain) which was racing outside TAKING SILK (K Ramsamy) was brushed out. Thereafter, TAKING SILK (K Ramsamy) was carried back in by IMPERIAL RAGE (J Allyhosain) which appeared to become unbalanced and shifted in.

Jockey R Joorawon (MOSCHINO) was found in contravention of Rule 147(6)(a)(ii) in that he struck the horse MOSCHINO with the whip more than 8 times before the 100m mark. Accordingly, a penalty of a fine of MUR 2,000 was imposed. The Jockey has been apprised of his right to appeal.

In view of the performance of IMPERIAL RAGE (J Allyhosain), the Veterinary Surgeon was requested to collect specimen for analysis.

**Stewards' Reports**



At the start, STAR OF ZEUS (J Allyhosain) was slowly away by two lengths.

Near 1100m, COPENHAGEN (D Schwarz) threw its head when steadied as the horse became keen when MAGNUM P I (M Sonaram) was ridden from its outside.

From the 700m, STAR OF ZEUS (J Allyhosain) was ridden around the horses on its inside and leaving the 600m, put pressure on COPENHAGEN (D Schwarz) who had to be eased.

App M Sonaram (MAGNUM P I) was issued a reprimand for allowing his horse to shift out in the final 100m under the continual use of the whip.

After the race, Jockey J Allyhosain was examined by the Medical Doctor on a complaint of exhaustion and was declared unfit to ride for the remaining engagements for the day. Consequently, he was replaced on his remaining rides. He will be required to produce a Medical Certificate before riding again.

Jockey J De Souza (LIVERPOOL CHAMP) was found in contravention of Rule 147(6)(a)(i), in that, prior to the 100m, he had used the whip on his horse more than once on consecutive strides in the running. Consequently, a fine of MUR 4,000 was imposed on him. He was advised of his right to appeal.

**Stewards' Reports**

KAMADEVA was scratched on Veterinary advice on 28<sup>th</sup> October 2022 at 7hr44. All bets on KAMADEVA were ordered to be refunded and betting to be reopened.

Apprentice M Sonaram (TOWER OF WISDOM) did not claim his 3kg allowance.

Jockey B Sooful (DUTCH ALLEY) carried 1kg over the carded weight and weighed out at 53kg.

Jockey A L Da Silva (CARTEL BOSS) carried 0.5kg over the carded weight and weighed out at 58kg.

CARTEL BOSS (A L Da Silva) was restless in the stall, jumped awkwardly inwards whereby the Jockey became unbalanced and went onto VALYRIAN KING (R Joorawon). As Jockey A L Da Silva regained balance in his saddle, CARTEL BOSS shifted out whereby, firstly ALRAMZ (D Bheekary), in anticipation, shifted out and brushed with MARAUDING (S Rama) and thereafter, ALRAMZ again shifted out and brushed with MARAUDING.

At the start, VALYRIAN KING (R Joorawon) was slowly away by a length.

After a slow start, VALYRIAN KING (R Joorawon) was racing fiercely and near 1200m was then eased off the heels of CARTEL BOSS (A L Da Silva).

Leaving the 1200m, TOWER OF WISDOM (M Sonaram) was eased off the heels of DUTCH ALLEY (B Sooful) and shifted out causing VALYRIAN KING (R Joorawon) to shift out. As TOWER OF WISDOM slowed due to the easing, ALRAMZ (D Bheekary), who was following, was eased and this horse raced unsettled between 1200m and 1000m.

Jockey R Joorawon (VALYRIAN KING) reported that his horse was keen during the running.

DUTCH ALLEY (B Sooful) lugged in, in the straight.

In view of the performance of CARTEL BOSS (A L Da Silva), the Veterinary Surgeon was requested to collect specimen for analysis.

**Stewards' Reports**

BETATHANTHEREST was scratched on Veterinary advice on 29<sup>th</sup> October 2022 at 8hr30. All bets on BETATHANTHEREST were ordered to be refunded and betting to be reopened. Acting on rule 118(d) of the Rules of Racing, the Emergency Acceptor, GANG LEADER, was accepted as a runner and had Jockey N. Teeha onboard.

At the start, SHORT CUT (M P De Oliveira) rolled out causing SUPREME ORATOR (I Taka) to shift out onto GANG LEADER (N Teeha) who went out onto I'M AL (M Sonaram) who brushed with KALGOORLIE (S Bussunt).

At the start, JACK TARR (S Rama) and DOUBLE GAMES (D Schwarz) brushed. After the start, KALGOORLIE (S Bussunt) was eased and brought behind runners.

Leaving the 1300m, DOUBLE GAMES (D Schwarz) was eased due to lack of room while on the inside of JACK TARR (S Rama).

Near 1000m, GANG LEADER (N. Teeha) was eased off the heels of MAURITIUS (A L Da Silva).

Near 300m, JACK TARR (S Rama) was eased off the heels of MAURITIUS (A L Da Silva).

Approaching 100m, SHORT CUT (M P De Oliveira) and DOUBLE GAMES (D Schwarz) shifted ground and brushed.

**Stewards' Reports**

HAKKEEM was scratched on Veterinary advice on 29<sup>th</sup> October 2022 at 16hr16. All bets on HAKKEEM were ordered to be refunded. Fixed odds winning bets were deducted by 7 cents per rupee on the face value of the ticket.



At the start, SWAGGER JAGGER (J De Souza) was slowly away by a length and VAR'S ELUSION (B Sooful) was slowly away by 2 lengths.

Leaving the 1300m, THOMAS HENRY (R Joorawon) stumbled.

Near 1200m, THOMAS HENRY (R Joorawon) was steadied.

Leaving the 1200m, SILVER HERITAGE (S Rama) was eased off the heels of CAPTAIN FLYNT resulting in VAR'S ELUSION (B Sooful), who was following SILVER HERITAGE, being eased.

Near 400m, THOMAS HENRY (R Joorawon) was eased off the heels of CULTURE TRIP (K Ramsamy).

After the race, Mr. G. Gujadhur, Assistant Trainer of Trainer Gujadhur, reviewed the race and expressed his dissatisfaction to Jockey R Joorawon's (THOMAS HENRY) ride from 500m onwards. The Stewards held a review of the riding of Jockey R Joorawon. Jockey R Joorawon confirmed that his instructions were not to bounce the horse and ride him from behind since the horse was carrying 61.5 kg and ride from the 400m.

With regard to the dissatisfaction expressed by Mr. G. Gujadhur, it was observed that near 600m THOMAS HENRY was one horse off the rail and was racing behind CULTURE TRIP and had SWAGGER JAGGER on its outside. Near 450m crossing, SWAGGER JAGGER was ridden from the outside of THOMAS HENRY whereby the latter did not have room to maneuver from its position. At this stage CULTURE TRIP was not responding to the urgings of its rider due to which THOMAS HENRY had to be eased due to the presence of SWAGGER JAGGER being on its outside and THOMAS HENRY was held up by Jockey R Joorawon until he was able to find room to ride between CULTURE TRIP and SWAGGER JAGGER. Thereafter, THOMAS HENRY was ridden to the post. In view of these observations, the matter was closed.

In the concluding stages of the race, SILVER HERITAGE (S Rama) was eased off the heels of CAPTAIN FLYNT (M P De Oliveira) who was hanging in.

**Veterinary Surgeon's reports**

HAKEEM – Swollen left knee – scratched.

**Other comments/Explanations:**

1. Pre-race blood specimens were taken from all starters which were reported to be negative.
2. In all races, all the riders were weighed in.
3. All the winners were selected for the taking of specimens for analysis as well as IMPERIAL RAGE (Race 3) and CARTEL BOSS (Race 6).
4. All riders were breathalysed and were cleared to ride.
