1. Prior to the commencement of this race, the instructions for all riders were taken by the Stipendiary Stewards. In this regard, each of the instructions matched the racing pattern of the horses, except for AFRICAN FATE (J. Allyhosain) where Trainer D. Zaki advised that the horse will be ridden to lead. This change of tactic was disseminated to the public.

Starting Reports

1. DAYLA VISTA (N. Batchameah) brushed the gates and was awkward at the jump.

Stewards Reports

1. DAYLA VISTA (N. Batchameah) was wide at the 450m and then weakened. Subsequently, Jockey N. Batchameah reported that the horse was not striding out. In view of this report, the Veterinary Surgeon was requested to examine.
2. AFRICAN FATE (J. Allyhosain) and MASTEROFALLISURVEY (R. Joorawon) shifted away from the whip in the straight.
3. ALPENHORN (B. Sooful) had a tendency to lay in, in the straight.
4. Jockey B. Sooful (ALPENHORN) appeared before the Board in relation to his riding in the in the final stages of the race, when ALPENHORN travelled behind AFRICAN FATE (J. Allyhosain) for a few strides, rather than being given a clear run to the finish. Jockey B. Sooful advised that at that stage, his horse was leaning in and AFRICAN FATE was shifting out and his horse ended up following AFRICAN FATE, however, that in his opinion, this did not have an effect in the final finish as his horse was not travelling well from the 400m and towards the end, it was tired and was a beaten horse in relation to the winner. He added

that the performance of the horse was disappointing. The Board noted the explanations of Jockey B. Sooful.

- An inquiry will be opened into Jockey R. Joorawon's riding on MASTEROFALLISURVEY in the closing stages of the race.

ADDITIONAL INFORMATION

1. Race Meeting 8 – 22 June 2024 - Race 6 - The Anjalay Coopen Cup

Jockey N. Marday signed an admission of guilt for a contravention of Rule 29.2.5 in that he struck the horse RIDGERUNNER with his whip more than once on consecutive strides in the running. Accordingly, a penalty of a fine of Rs 2, 000 was imposed.

2. Race Meeting 08 – 22nd June 2024 - Race - The Camp Diabie Federation Sporting Club Cup

An inquiry was held at the Office of the HRD on 02nd July 2024 and Jockey R Boutanive (CLOUDED HILL) was interviewed. Subsequently, Jockey R Boutanive was charged with a contravention of Rule 43.2.1, in that, he failed to take all reasonable and permissible measures throughout the running of the race in order to ensure that his horse was given a full opportunity to win or obtain the best possible placing in that race.

Jockey R Boutanive pleaded not guilty to the charge, however, the Board found him guilty.

After considering the evidence in this matter, the Inquiry Board imposed a penalty of a suspension from riding in races for a period covering 06 Race Meetings.

Jockey R Boutanive has the right of appeal against the charge and the penalty imposed.

3. Race Meeting 08 – 22nd June 2024 - Race - The Democratising of Horseracing by Leasing Cup

An inquiry was held at the Office of the HRD on 03rd July 2024 and Jockey M Sonaram (SKATING ON ICE) was interviewed, along with Trainer SP Nagadoo, who was assisted by his Assistant Trainer U Nagadoo. Subsequently, Jockey M Sonaram was charged with a contravention of Rule 43.2.1, in that, he failed to take all reasonable and permissible measures throughout the running of the race in order to ensure that his horse, SKATING ON ICE, was given a full opportunity to win or obtain the best possible placing in that race.

Jockey M Sonaram pleaded not guilty to the charge, however, he was found guilty.

After considering the evidence in this matter, the Inquiry Board imposed a penalty of a suspension from riding in races for a period covering 12 Race Meetings.

Jockey M Sonaram has the right of appeal against the charge and the penalty imposed.
