1. AL JAZEERA (M. De Oliveira) reared up as the start was given, was slowly away and then brushed with SMUTS (S. Rama).
2. JET ORBIT (S. Bhundoo) was slowly away by two lengths.

**Stewards Reports**

1. After jumping out slow, AL JAZEERA (M. De Oliveira) was keen in the running and had to be ridden with restraint until about the 900m.
2. JET ORBIT (S. Bhundoo) commenced to give ground to the field at the 1300m, and finished detached. In view of the performance of JET ORBIT, Trainer C. Ramdin will be advised that should this gelding not become more competitive, it may be suspended. Additionally, in view of the performance of JET ORBIT, the Veterinary Surgeon was requested to examine.
3. Near the 600m, FRENCH REBEL (S. Donohoe) shifted in, tightening SMUTS (S. Rama) which lost ground. Jockey S. Donohoe will be issued with a warning.
4. After the running of this race, Jockeys R. Joorawon and S. Donohoe appeared before the Board and advised that the track was on the softer side but was consistent and race worthy.

1. JACK TARR (B. Ecoignard) jumped out awkwardly.
2. VARTACUS (C. Goolgar) fly jumped.

**Stewards Reports**

1. Shortly after the start, JACK TARR (B. Ecoignard) and CRUSHING FORCE (K. Roussety) brushed due to VARTACUS (C. Goolgar) shifting in.
2. NEVIIL MU (N Batchameah) hung in in the straight.
3. Trainer R. Maingard and Apprentice B. Ecoignard (JACK TARR) appeared before the Board in relation to the instructions. Trainer R. Maingard advised that he asked Apprentice B. Ecoignard to jump well, not to cut pace with other runners, not to travel wide and not to use the whip as the Apprentice becomes unbalanced while doing so. Trainer R. Maingard was specifically questioned with regards to the Apprentice electing to remain behind CAMPS BAY (I. Taka), resulting in him holding his horse for a few strides rather than travelling around CAMPS BAY. Trainer R. Maingard explained that this was in accordance with his instructions and was of the view that this had benefitted the horse. The Board noted the explanation of Trainer R. Maingard, however, he was advised by the Stewards that the reasonableness of instructions were to be measured against the circumstances of the race and this would be monitored by the Stewards going forward.

**Starting Reports**

1. NIGHT KING (S. Donohoe) jumped awkwardly.
2. GOETHE jumped awkwardly with Jockey R. Perez hitting his right leg onto the gate, losing his right stirrup which he regained shortly.

**Stewards Reports**

1. Leaving the stalls, SPRY (B. Ecoignard) shifted out resulting in ACTION PACKED (K. Ramsamy) shifting away and in turn causing MASTER OF ILLUSION (K. Bhageeruthy) to shift further out and became tightened on the heels of RED IMPACT (B. Sooful) which was awkwardly placed on the inside of NIGHT KING (S. Donohoe).
2. RED IMPACT (B. Sooful) lost its action in the running from the 600m and tailed off. In view of the performance of this gelding, the Veterinary Surgeon was requested to examine.
3. Near 300m, ACTION PACKED (K. Ramsamy) had to ease when awkwardly placed on the inside of NIGHT KING (S. Donohoe). An inquiry has been opened into this incident.
4. Jockey R. Perez (GOETHE) used his whip on the shoulder of the horse in a drawn position due to his horse hanging in and being placed close on the outside of SPRY (B. Ecoignard). Taking the circumstances into consideration, no action was initiated in the matter.
5. Jockey K. Ramsamy (ACTION PACKED) appeared before the Board and advised that he experienced kick back during the running of the race and was unable to see properly. Further, his horse was not striding out in the running and then near 300m, his horse was interfered with by NIGHT KING (S. Donohoe) which resulted in his horse losing action in the running. He believed that the horse may have bled again as had been the case in its previous start and accordingly, did not ride ACTION PACKED (K. Ramsamy) in the straight with his normal vigour. Jockey K. Ramsamy was advised to continue riding his



horses to the finish in future and additionally, the horse was referred to the Veterinary Surgeon.
