**General**

1. The start of this race was delayed due to GOOD BUDDY (J. Allyhosain) which proceeded to the start directly from the stables, being presented incorrectly equipped. This horse was subsequently withdrawn by the Stipendiary Stewards. An inquiry will be opened into this matter.
2. Prior to the running of this race, Trainer N. Rawat advised the Board that his instructions to Apprentice J. Sophie were to ride WAIMEA in order to test for the lead, however, in the event that he could not lead, he had the option to allow the horse to either race outside the leader or find cover, if possible under the circumstances.

**Starting Report**

1. FRENCH REBEL (N. Batchameah) lost two lengths.

**Stewards Reports**

1. From its wide draw, WAIMEA (J. Sophie) was ridden aggressively in order to obtain a forward position and ultimately was positioned outside the leader.
2. DAYLA VISTA (R. Joorawon) raced fiercely in the early and middle stages. Subsequently, Jockey R. Joorawon reported that there was something amiss with DAYLA VISTA in the running and did not persevere with his riding from the 450m. In view of this report, the Veterinary Surgeon was requested to examine.
3. WHIPPING BOY (N. Teeha) shifted out away from the whip in the concluding stages.
4. An inquiry will be opened in order to establish why SMUTS (S. Rama) had to ease at the 500m.
5. An inquiry will be opened in order to establish why LITTLE PAL (M. Sonaram) had to ease at the 1200m.
6. FRENCH REBEL (N. Batchameah) was hanging in, from the 500m. An inquiry will be opened into Apprentice N. Batchameah riding of in this race.

1. CARBON FIBRE (M. Sonaram) raced wide in the early stages. Thereafter, this horse failed to negotiate the turn at the 900m, shifted out, refused to gallop and was not persevered with by Apprentice M. Sonaram.
2. HIGH KEY (J. Allyhosain) was baulked for a clear from the 400m to the 300m.
3. TAKING SILK (B. Sooful) was baulked for a clear run between the 350m and the 300m.
4. LAMBORGHREENI (R. Joorawon) was hanging in, in the straight.
5. Jockey R. Joorawon signed an admission of guilt for a contravention of Rule 29.2.13 in that he struck the horse LAMBORGHREENI with the whip more than 7 times before the 150m. Accordingly, a penalty of a fine of Rs 2,500 was imposed.
6. In view of the behaviour of CARBON FIBRE (M. Sonaram), this horse has been suspended for 30 days and until proving tractable in the running.

2. Between the 1300m and 1200m, ABSOLUTIST (R. Joorawon) had to be restrained off heels on at least two occasions whilst overracing.
3. At the 500m, ROYAL WULFF (B. Sooful) struck the rail after Jockey B. Sooful elected to take a tight run on the inside of THE DAZZLER (N. Marday). This resulted in THE DAZZLER being carried out and HAYLOR (K. Kalychurun) in turn being carried out at the 500m. Subsequently, HAYLOR raced wide for the remainder of the turn.
4. Jockey B. Sooful (ROYAL WULFF) appeared before the Board, was shown the patrol films of the race and was cautioned regarding his decision to take such a tight run and advised that should there be a similar occurrence in the future, more severe sanctions will follow.
5. Between the 400m and 300m, ROYAL WULFF (B. Sooful) had to ease when awkwardly placed on the heels of SUPER EXCITED (M. Sonaram). Thereafter, ROYAL WULFF was directed to be outside of the track to make its run.
6. SUPER EXCITED (M. Sonaram) was hanging in, in the straight. An inquiry has been opened into the riding of Apprentice M. Sonaram riding of SUPER EXCITED in this race.
7. Jockey B. Sooful (ROYAL WULFF) was reported to have injured his right leg after the running of the race. A medical report will be required prior to him riding again.

## **ADDITIONAL INFORMATION**

### **1. Race 3 - The Mare D'albert Celtic Association Cup and Race 4 - The 100th Edition Of "Le Vrai Débat" Cup**

Jockey J. Bardottier was replaced on his rides. Additionally, the Stipendiary Stewards have restricted him to 61kg rides only.

Jockey J. Bardottier signed an admission of guilt for a contravention of Rule 32.4 in that he weighed out at more than 1kg over the weight at which he was carded to ride SENOR DON. Accordingly, a penalty of a fine of Rs 5,000 was imposed.

### **2. Race Meeting 28 – 16 September 2023**

Trainer A. Rahmathulla signed an admission of guilt for contravention of the General Conditions of the Race Meeting 28 in that he nominated his horse TICKET TO CAIRO, a Winner, to race at this race meeting whilst races were reserved for horses not placed first within a specific period. Accordingly, a penalty of a fine of Rs 5,000 was imposed.

### **3. Race Meeting 26 – 2 September 2023 – Race 1 - The Younty Association Of Petit-Raffray Cup**

Apprentice M. Sonaram signed an admission of guilt for a contravention of Rule 43.2.9 in that whilst riding the horse DUKE OF ABERCORN, he failed to ensure that he did not excessively slow, reduce or check the speed of his horse, thereby causing interference to CRACKON (S. Donohoe) at the 1200m. Accordingly, a penalty of a suspension of 1 race meeting and a fine of Rs 10,000 was imposed.

### **4. Race Meeting 26 – 2 September 2023 - Race 8 - La Chaux Academy Cup**

Jockey I. Chisty signed an admission of guilt for a contravention of Rule 29.2.15 in that he used his whip down the shoulder of STRAIGHT, whilst in the drawn position. Accordingly, a penalty of a fine of Rs 2,000 was imposed.

### **5. Race Meeting 25 – 26 August 2023 – Race 3 - The « Force Vive Clémencia/Belle-Rose » Cup**





Jockey B. Sooful signed an admission of guilt for a contravention of Rule 29.2.15 in that he used his whip down the shoulder of CANARY ISLAND, whilst in the drawn position. Accordingly, a penalty of a fine of Rs 2,500 was imposed.

**6. Race Meeting 24 – 19 August 2023 – Race 8 - The « Force Vive De Camp Diable » Cup**

Jockey R. Perez signed an admission of guilt for a contravention of Rule 29.2.5 in that he struck the horse CULTURE TRIP with his whip more than once on consecutive strides in the running. Accordingly, a penalty of a fine of Rs 2,000 was imposed.
