# **Stewards Reports**

- In view of the Starting Report, the starting stall certificate for ITDAWNEDONME (S. Donohoe) has been withdrawn. This gelding has been suspended by the Stewards for thirty days after which, it will be required to complete a jump out in a barrier trial to the satisfaction of the Stewards.
- 2. SENOR DON (J. Allyhosain) hung in, in the straight, proving difficult to assist.

Jockey J. Allyhosain appeared before the Board and was afforded the opportunity to place on record any factors which, in his opinion, contributed to the poor performance of SENOR DON. In this regard, he could afford no explanation for the performance. He merely stated that he had intended to lead, however, WILLIAMTHEFIGHTER (R. Perez) was faster and after securing the position behind the leader moving through the 600m, he felt that his horse would have nothing to come in the finish. In view of the performance of SENOR DON, the Veterinary Surgeon was requested to examine. Trainer Y. Emamdee will be requested to report back on the condition of SENOR DON upon return to the stables.

- 3. In the concluding stages, WILDE WORLD (R. Joorawon) shifted out sharply away from the whip.
- Jockey J. Bardottier reported that VIKING TRAIL did not stride out freely in the running. In view of this report, the Veterinary Surgeon was requested to examine.

 Prior to the start of this race meeting, the Stipendiary Stewards were advised by the Mauritius Broadcasting Corporation (MBC) that the 1850m camera was not functioning and could not be repaired for today's race meeting. Accordingly, permission was granted by the Stipendiary Stewards in order for other angles to be used in relation to that area. Additionally, two Stipendiary Stewards were dispatched to the 1850m, in order to provided necessary evidence to the Board where required.

The Jockeys were consulted in respect of the above matter and were given the option whether or not to continue with their engagement at the race meeting and each elected to ride.

2. 30 September 2023 – Race Meeting 30 – Race 3 - The RL Musical Family Cup

Jockey S. Rama signed an admission of guilt for a contravention of Rule 43.2.2 in that as the rider of the horse CLOUD SEEDER, he failed to ensure that he did not cause interference to STRAIGHT (I. Chisty) and TRAVELIN MAN (C. Segeon) at the 1300m. Accordingly, a penalty of a suspension of one race meeting and a fine of Rs 10,000 was imposed.
