**Stewards Reports**

1. Leaving the 500m, CAPTAIN'S CONSORT (M. De Oliveira) was ridden from the outside of ROYAL VIRTUE (K. Bhageeruthy) and at the same time FRENCH REBEL (J. Bardottier) was ridden forward and near the 450m, SHESH BESH (K. Ramsamy) was eased when becoming unbalanced coming over the crossing while racing on the inside of FRENCH REBEL. SHESH BESH lost ground due to the ease, inconvenienced ARNICA MONTANA (I. Taka), which was eased severely. As a consequence of this incident, SHESH BESH and ARNICA MONTANA were eased out of the race. It was deemed to be a racing incident.
2. BENEV (S. Bhundoo) found it difficult to keep pace for most part of the race.

### **Stewards Reports**

1. Approaching the 1300m, CHARLIE SQUADRON (C. Goolgar) stumbled and shifted out, subsequently tightening SIEGE RAM (R. Joorawon).
2. Apprentice I. Taka (CYBOTIX) reported that his horse was hanging in during the race. Apprentice I. Taka appeared before the Board and was asked to place on record any contributing factors in relation to the performance of CYBOTIX. He explained that after jumping well, he wanted to be one off the fence but he did not get the opportunity due to WINTER GUARD (S. Rama) being on his inside and instead of bringing his horse back and tuck him behind WINTER GUARD, he chose to ride his horse to be in front of WINTER GUARD. However, he did not get that opportunity also, therefore, he had no option but to travel wide, on the outside of WINTER GUARD until the 900m.  
In view of the performance of CYBOTIX, the Veterinary Surgeon was requested to examine.  
Subsequently, Trainer S. Narang lodged a verbal complaint against Apprentice I. Taka's riding in this race in view of which, a review of Jockey I. Taka's riding will be undertaken.

3. Trainer S Narang requested permission, which was granted, to substitute Apprentice I Taka on WAR BANNER.

Prior to the running of the race, Jockey S Donohoe appeared before the Board stating him being unhealthy to ride today and was sent for Medical attention and was subsequently, declared medically unfit to ride.

### **Starting Reports**

1. BACKPACKER (D. Bheekary) jumped awkwardly outwards, brushed LIVERPOOL CHAMP (P. Horil), who tightened LAMBORGHREENI (I. Taka) onto PROSPECTOR

(M. De Oliveira) causing LAMBORGHREENI & LIVERPOOL CHAMP to be squeezed out.

### **Stewards Reports**

1. Leaving the stalls, Jockey M. De Oliveira (PROSPECTOR) used his whip down the shoulder in a drawn position, thereby contravening rule 29.2.15. Accordingly, Jockey M. De Oliveira was issued with a reprimand.
2. LAMBORGHREENI (I. Taka) hit the rail at the 600m and became severely unbalanced, and was subsequently eased out of the race.
3. Jockey K. Ramsamy reported that DIVERGENT was not striding out in the running. In view of this report, the Veterinary Surgeon was requested to examine.
4. Jockey P Horil (LIVERPOOL CHAMP) when queried about his riding stated that he found it difficult to ride his horse evenly due to the long mane to which he was not used to. He was reminded of his obligation to report all circumstances which may affect his riding.
5. Jockey M De Oliveira (PROSPECTOR) appeared before the Board and shown the patrol film of the race near the finish and was advised to ride his horses so as not to leave any room for query.
6. DIVERGENT (K Ramsamy) found it difficult to keep pace with the field in the early stages.
7. Jockey P Horil (LIVERPOOL CHAMP) used his whip down the shoulder in a drawn position, thereby contravening rule 29.2.15. Accordingly, Jockey P Horil was issued with a reprimand.
