- 1. Leaving the stalls, App K Jeetun (PETE THE PILOT) lost right side rein and was unbalanced momentarily.
- 2. CARINO BELLO (J. Sophie) overraced in the early stages.
- 3. Approaching the 1200m, PETE THE PILOT (K. Jeetun) shifted in, went across RAVISHING RAMBO (B. Soodoo), causing that horse to shift out. PETE THE PILOT shifted in further causing PROTECTIVE LIGHT (K. Roussety) to ease. Apprentice K. Jeetun has been severely reprimanded.
- 4. RAVISHING RAMBO (B. Soodoo) was hanging in, in the running.
- 5. Near the 200m, PETE THE PILOT (K. Jeetun) shifted in sharply under the use of the whip and thereafter was hanging in, in the straight.

- 5. The side winkers on the right side of the bridle of KALI'S CHAMP (S. Bhundoo) fell off during the running near 350m. Trainer C. Ramdin has been issued with a reprimand.

- 1. Jockey I. Chisty (JOHN HANCOCK) appeared before the Board in relation to him showing no intent in the early stages of the race and travelling wide for most part of the race. The Jockey explained that when his horse stumbled at the start, and the horse's head hit his face, he was dazed for some time. Further, in order to avoid kickbacks from the front runners, he elected to travel wide. Furthermore, he has been advised to report all circumstances which might affect the running of his horses. The Stipendiary Stewards noted the explanations of Jockey I. Chisty.
- 2. ARNHEM LAND (B. Ecroignard) hit the rail at the 450m crossing and became unbalanced.

Prior to the running of race 7, a panel consisting of Jockeys, R. Joorawon and J. Allyhosain, the Stipendiary Stewards, Track Manager and the Clerk of the Course inspected the track, specifically near the 600m and in consultation with the PTP PLC representative, it was decided to abandon races 7 and 8 due to the persisting rain rendering the underfoot conditions nonconducive for racing.



Other comments/Explanations:

- 1. Pre-race blood specimens were taken from all starters and all returned negative.
- 2. In all races, the riders were weighed in.
- 3. All the winners were selected for the taking of specimens for analysis as well as BIG SMOKE (race 2).
- 4. All riders were breathalyzed and cleared to race.

- 1. An inquiry has been opened into an incident as to why PETE THE PILOT and I'M AL did not jump from their allocated draws in Race 1.
- 2. 4 November 2023 Race Meeting 36 Race 6 The Kranti Women Association Cup Jockey B. Sooful signed an admission of guilt for a contravention of Rules 29.2.5 and 29.2.15 in that he struck the horse ROYAL WULFF with his whip more than once on consecutive strides and used his whip down the shoulder of the horse, whilst in the drawn position. Accordingly, a penalty of a fine of Rs 3,000 was imposed.
- 2. 7 October 2023 Race Meeting 32 Race 3 The World Health Mental Day Cup Jockey M. De Oliveira signed an admission of guilt for a contravention of Rule 29.2.5 in that he struck the horse COLOUR OF MONEY with his whip more than once on consecutive strides in the running. Accordingly, a penalty of a fine of Rs 3, 000 was imposed.
