1. CHESTNUT COVE (J. Allyhosain) and GONTRAVELIN (R. Kulloo) were slowly away.

Stewards Reports

- 1. AFRICAN ROCK (M. Chinapiel) raced keen in the early part of the race.
- Approaching 1500m, THE GYPSY KING (J Bardottier) commenced to shift in and due to this movement, AFRICAN ROCK (M. Chinapiel) shied away and brushed with ROMANUS (R. Joorawon) near 1500m. Jockey J Bardottier has been advised to be careful while shifting ground.
- 3. Near the 1400m, as THE GYPSY KING (J. Bardottier) was being settled, shifted out causing AFRICAN ROCK (M. Chinapiel) to shift out further, due to which SUPREME ELEVATION (K. Ramsamy) was forced to travel wide.
- 4. AFRICAN ROCK (M. Chinapiel) overraced in the early stages and passing the 800m, went into the lead.
- 5. Passing the 450m crossing, AFRICAN ROCK (M. Chinapiel) shifted out causing THE GYPSY KING (J. Bardottier) and SUPREME ELEVATION (K. Ramsamy) to travel wide.
- 6. Near the 300m, CHESTNUT COVE (J. Allyhosain) was eased while racing on the inside of AFRICAN ROCK (M. Chinapiel).

- 2. A race review was called into the start of this race pertaining to ARIZONA SILK (M. Sonaram) drawn in stall 1 being slow. In this regard, Apprentice M. Sonaram stated that the horse was restless in the stall and showed a tendency of rearing up as the start was effected, which caused the horse to jump out slow. In assessing this incident, the Board was of the view that any prejudice suffered by ARIZONA SILK was a consequence of its own behaviour. The horse was deemed to be a runner.
- 2. Jockey J Allyhosain (FREE TO WIN) appeared before the Board and was shown the patrol films of the race in relation to his ride. The Jockey explained that it was their strategy to let LUNAFACATION (B. Sooful) take the lead if that horse insisted and he was to ride his horse with the pace and beat LUNAFACATION in the sprint. He added that his horse was travelling well in the race and he was in a box seat till the 450m. At that stage, his horse was travelling well. However, when he intended to ride from the outside of LUNAFACATION, near the 300m, the horse did not respond. He further stated that it was not the same horse that he won on last time. In view of the performance of the horse, Veterinary Surgeon was requested to examine.
