#### General

1. Prior to the commencement of this race, the instructions for all riders were taken by the Stipendiary Stewards. In this regard, each of the instructions matched the racing pattern of the horses.

#### **Starting Reports**

- 1. LORD OF LIGHT (N. Teeha) lost one length.
- 2. WILLIAMTHEFIGHTER (R. Perez) was squeezed out.

#### **Stewards Reports**

- 1. Shortly after the start, SILVER DUCAT (K. Ramsamy) had to ease when awkwardly placed between JACK TARR (T. Ladouceur) which rolled in marginally and BROADWAY ALLEY (T. Juglall) which jumped out.
- 2. At the 800m, DOUBLETHINK (M. Sonaram) struck the rail when awkwardly placed on the inside of JACK TARR (T. Ladouceur) which shifted in. As a consequence of this incident, SILVER DUCAT (K. Ramsamy) was momentarily inconvenienced when awkwardly placed on heels. Thereafter, between the 600m and the 400m, DOUBLETHINK had to be restrained off heels on a number of occasions.
- 3. VARTACUS (M. De Oliveira) and JACK TARR (T. Ladouceur) were hanging in, in the straight.
- 4. Apprentice T. Ladouceur signed an admission of guilt for a contravention of Rule 43.2.2 in that as the rider of the horse JACK TARR, he failed to ensure that he did not cause interference to DOUBLETHINK (M. Sonaram) at the 800m. A suspension from riding in races for a period of two race meetings was imposed. Additionally, Apprentice T. Ladouceur will be required to complete a further two barrier trials to the satisfaction of the Stipendiary Stewards prior to riding again.
- 5. An inquiry will be opened in order to establish why WILLIAMTHEFIGHTER (R. Perez) entered the paddock late.



6. An inquiry will be opened into Apprentice M. Sonaram (DOUBLETHINK) riding in this race.

1. Between the 1700m and the 1200m, GORDONSTOUN (M. Mudhoo) and WILDE WORLD (D. Bheekary) both showed an intent to lead. This resulted in both these horses racing in a clear lead in the early stages.



- 2. GORDONSTOUN (M. Mudhoo) raced wide between the 1600m and the 1400m. Thereafter, GORDONSTOUN struck the rail entering the straight.
- 3. NIMITZ (R. Joorawon) was baulked for a clear run between the 400m and the 300m. Thereafter, at the 150m, NIMITZ which was hanging in, in the straight, had to ease and shift out when running onto the heels of EAGLES VISION (N. Batchameah).
- 4. Between the 400m and the 300m, TAKING SILK (R. Perez) had to ease when awkwardly placed on the heels of the tiring GORDONSTOUN (M. Mudhoo). Thereafter, TAKING SILK, shifted away from the whip at the 75m.

#### **Stewards Reports**

- 1. From the jump, CLOUD SEEDER (S. Rama) and INSTINCTIVE POWER (S. Donohoe) were ridden aggressively in order to lead. However, approaching the 1000m, CLOUD SEEDER elected to restrain and take a trail. This resulted in CLOUD SEEDER briefly being inconvenienced at the 700m when INSTINCTIVE POWER (S. Donohoe) crossed to the rail.
- 2. KING OF COLTS (M. Sonaram) raced awkwardly from the 600m.
- 3. Jockey S. Donohoe reported that the saddle on INSTINCTIVE POWER slipped back in the running. This was confirmed by a member of the Board.
  - Jockey S. Donohoe appeared before the Board and was questioned regarding the frequency of his saddle slips recently. In this regard, he explained that the manner in which horses were being saddled were, in his opinion, not suited to his style of riding which was the reason for the frequency of the slips. Jockey S. Donohoe was advised by the Board to ensure that when checking his saddle, if he is unhappy, he ought to resaddle his horse, if necessary.
- 4. GLOBAL GLORY (M. De Oliveira) was hanging in, in the concluding stages.
- 5. In the concluding stages, INSTINCTIVE POWER (S. Donohoe) showed a tendency to drift out.
- 6. Jockey O. Sola appeared before the Board, was shown the patrol films of the race and advised against the practice of using his whip down the shoulder of his horse (GO JEWEL) while in the drawn position. Jockey O. Sola was issued with a warning.

- 1. In view of the Starting Report, the starting stall certificate for NOBLE TRIP (K. Ramsamy) has been withdrawn. This gelding has been suspended by the Stipendiary Stewards for seven days after which, it will be required to complete a jump out in a barrier trial to the satisfaction of the Stewards.
- 2. SAND PATH (I. Taka), CAPTAIN PERSIA (N. Marday) and KALGOORLIE (B. Bhaugeerothee) raced wide around the turn and into the straight.
- 3. At the 200m, CAPTAIN'S CONSORT (M. De Oliveira) switched in to continue its run when awkwardly placed on outside of GOOD BUDDY (G. Aucharuz) which was hanging in, in the straight.



4. Jockey B. Bhaugeerothee (KALGOORLIE) appeared before the Board, was shown the patrol films of the race and advised against the practice of using his whip more than once on consecutive strides in the running. Jockey B. Bhaugeerothee was issued with a warning.
