JOCKEY CHANGES

Race 6, Jockey A L Da Silva was replaced by Jockey R Joorawon on HENRY TUDOR.

Race 8, Jockey A Andrews was replaced by Jockey R Joorawon on SECRET CIRCLE.

Stewards' Reports

At the start, ITALIAN WAY (B Sooful) jumped awkwardly outwards and caused a chain reaction in which BONJOUR BABY (I Taka), STREET BYTE (M P De Oliveira) and THE RIGHT STUFF (S Rama) shifted out. In this incident, STREET BYTE made contact with CELESTIAL MAGMA (J De Souza) and then STREET BYTE was steadied off the heels of CELESTIAL MAGMA (J De Souza).

CELESTIAL MAGMA (J De Souza) hung in, in the straight.

Jockey D Schwarz (SACRED NIGHT) was questioned with regards to him becoming unbalanced in the straight, particularly in the concluding stages of the race and it seemed that the Jockey could not assist his horse properly. Jockey D Schwarz explained that his horse was leaning in and whilst trying to keep his horse run straight. However, whilst endeavoring to get SACRED NIGHT to the finish, he unbalanced himself. The Board noted the explanations of Jockey D Schwarz and advised him his riding will continue to be monitored.

Jockey J De Souza (CELESTIAL MAGMA) was observed to have used his whip in consecutive strides in the running prior to the 100m. He was found in contravention of Rule 147(6)(a)(i), in that, he admitted to have struck the horse, CELESTIAL MAGMA, more than once on consecutive strides in the running and signed an admission of guilt. Consequently, a penalty of Rs 3000 was imposed on him.

STEEET BYTE – Bled both nostrils – 30 days suspension confirmed.

SACRED NIGHT – Not striding out.

DUNZIE (M P De Oliveira) was fractious in its stall.

At the start, CAPTAIN FALCON (S Bussunt), HONOKALANI (L Goomany) and NOBLE TRIP (A L Da Silva) were slow to begin.

Approaching the 800m, HONOKALANI (L Goomany) scraped the rails.

CAPTAIN FALCON (S Bussunt) who raced keen near the 500m was steadied while going over the crossing at the 450m.

Near the 300m, CHARLIE SQUADRON (A Andrews) lost position while racing between YOHO MIST (J Da Silva) and MAGNUM P I (N Teeha) due to which HONOKALANI (L Goomany) who was following, had to be steadied.

In the concluding stages of the race, HONOKALANI (L Goomany) shifted out and went across MAGNUM P I (N Teeha).

Jockey C Maujean (SYDS LIASON) reported that his horse was finding it difficult to keep up with the pace and he had to ride it throughout the race. The horse was referred to the Veterinary Surgeon.

Jockey A Andrews (PADRE PIO) carried 1kg overweight and weighed out at 53 kg.

STREAM AHEAD (M P De Oliveira) was hanging in over the final 200m placing his rider at a disadvantage in riding his mount out to the finish. Further, Trainer C Daby will be advised to rectify the trait of this gelding.

Jockey L Goomany (NOURBESE) reported that his horse was intimidated by the presence of STREAM AHEAD (M P De Oliveira) in its close proximity.

Stewards' Reports

The Clerk of Scales reported that Jockey A L Da Silva (HENRY TUDOR) was weighing out at 56kg which was 2kg over the carded weight. However, permission was given to him to carry only 1kg overweight. In view of this, a change of Jockey was permitted and Jockey R Joorawon replaced Jockey A L Da Silva.

Subsequently, Trainer S Hurchund, Jockey A L Da Silva, along with his translator, were questioned in this regard. Evidence was taken from Trainer C Daby also. The Jockey was found guilty of contravening Rule 160 of the Rules of Racing, in that, he had accepted a ride whilst he was overweight. As a consequence, a fine of Rs 2500 was imposed on him and he was advised of his right to appeal.

Jockey B Sooful (ZIVA LA WINTER) reported that his face hit the horse's head in the stalls and he was on the verge of blacking out, but somehow finished the race.

ALRAMZ (L Goomany) became keen near 600m and near the 450m crossing ran into the heels of CARTEL BOSS (A Andrews) and was checked.

MARAUDING (S Rama) was wide at the home turn and lugged in, in the straight.

The race was delayed as the off fore shoe of GO JEWEL (D Schwarz) came off and had to be refitted.

ALASKAN NIGHT (J Da Silva) and GANG LEADER (N Teeha) were restless in the stalls.

Near the 300m, GOOD BUDDY (C Maujean) clipped heels of JAYS DANCER- (J De Souza) and lost position.



GANG LEADER (N Teeha) hung in, in the straight more so in the concluding stages and made contact with ALASKAN NIGHT (J Da Silva) on more than one occasion. Further, Trainer V Ruhee will be advised to rectify the trait of this horse.

The Medical Officer attended to Jockey A Andrews after the race and declared him unfit to ride. Acting on the advice of the Medical Officer, Jockey A Andrews was replaced for his remaining engagement by Jockey R Joorawon.

At the start, ROMANUS (S Bussunt) shifted out after an awkward jump and went on to SECRET CIRCLE (R Joorawaon) who went on to INAUGURATION (A Roy). INAUGURATION had also shifted in as GLOBAL SPECTRUM (M Sonaram) shifted in and made contact with INAUGURATION (A Roy).

Near the 200m, SAND PATH (M P De Oliveira) hung out and carried OPAGUE (J Allyhosain) outwards who then went across ROMANUS (S Bussunt) causing the latter to be steadied.

Further, Trainer C Daby will be advised to rectify the trait of SAND PATH.

GLOBAL SPECTRUM - No abnormalities detected.
