Starting Reports

1. AL JAZEERA (M Sonaram) and XENON (N S Batchameah) lost one length, respectively.

Stewards Reports

1. AL JAZEERA (M Sonaram) overraced between the 1300m and 700m.
2. CAPTAIN FALCON (J Sophie) briefly raced wide at the 1250m.
3. Between the 1200m and the 900m, HARDFALLINGRAIN (I Taka) raced ungenerously and was inclined to get its head up. Thereafter, between 150m and 75m, HARDFALLINGRAIN (I Taka) shifted in away from the whip and shifted out away from the whip in the concluding stages. As a consequence of this gelding's initial movement in, it had to be sharply corrected in order to avoid making contact with the inside running rail at approximately the 80m. Apprentice I Taka, appeared before the Board, was shown the patrol film of the race and advised to take stronger and faster corrective measures so as to prevent a similar occurrence in future.
4. At the 450m, XENON (N S Batchameah) angled off the rail to commence its run. However, after CAPTAIN FALCON (J Sophie) rolled out marginally, Apprentice N S Batchameah switched XENON back to the inside of CAPTAIN FALCON and instead made his run from between runners.
5. Apprentice J Sophie (CAPTAIN FALCON) and Trainer Gujadhur appeared before the Stewards' Panel and were advised that Apprentice J Sophie was not entitled to carry a



whip during his first ten rides according to Rule 104A(5). A reprimand has been issued to Apprentice J Sophie.

- Jockey A L Da Silva (THE HITMAN) carried 1kg over the carded weight of 57kg and weighed out at 58.10kg.

Starting Reports

- CITADEL (I Taka) lost a length at the start.

Stewards Reports

- WHIPPING BOY (S Bussunt) overraced between 1700m and 1300m.



2. THE HITMAN (A L Da Silva) which was hanging in from the 400m, brushed the inside rail entering the straight.
3. Jockey A L Da Silva (THE HITMAN) appeared before the Stewards' Panel and was questioned regarding his instructions on THE HITMAN in this race. In this regard, he, assisted by his translator, explained that he had intended to sit in a forward position. Consequently, as this is a lazy horse, he rode this gelding aggressively from the gates but this unexpectedly resulted in it taking a hold of the bit and pulling itself to the lead. Trainer S Hurchund also appeared before the Board and was questioned regarding the racing instructions on the THE HITMAN. In this regard, he confirmed the statements of Jockey A L Da Silva, which included the lazy characteristic of this horse. Trainer S Hurchund was also of the view that this horse had unexpectedly taken hold of the bit, which resulted in it taking the lead, contrary to the original plan for the race.
4. Jockey A L Da Silva signed an admission of guilt for contravention of Rule 147(5)(a) in that he used his whip down the shoulder of THE HITMAN, whilst in the drawn position and Rule 147(6)(a)(ii) in that he struck THE HITMAN with the whip more than eight times. Accordingly, a penalty of a fine of Rs 2500 was imposed.
5. CITADEL (I Taka) shifted out away from the whip between the 150m and the 100m.

1. GOETHE (S Bussunt) was restless in the gates.

Stewards Reports

1. ROMAN DANCER (I Taka) and TRIP TO THE SKY (B Sooful) were restrained to obtain rearward positions from the jump.
2. JUNIPER LANE (J De Souza) was ridden aggressively from the start, raced around the field and to the lead at the 1100m.
3. Between 1100m and 900m, ROMAN DANCER (I Taka) overraced. Thereafter, approaching the 400m, ROMAN DANCER (I Taka) which had commenced to make its run, was carried wide by DONNAN (M Sonaram) which switched out off the inside running rail in order to secure a clear running for itself. Thereafter, DONNAN (M Sonaram) was hanging in, in the straight.
4. Entering the straight, Jockey S Bussunt's (GOETHE) whip brushed the inside running rail.
5. ROMAN DANCER (I Taka) raced wide around the turn and into the straight.
6. At the 250m, TRIP TO THE SKY (B Sooful) switched in to continue its run. This resulted in this gelding becoming momentarily unbalanced.

1. TRANSONIC (J De Souza) and OPAGUE (S Bussunt) lost a length, respectively.
2. SILKEN PRINCE (A L Da Silva) and CARLAS MAMBO (B Sooful) came together and brushed.

Stewards Reports

1. Prior to the start of this race, Trainer S Mahadia informed the Stewards that he had intended to lead with MASSIMO (I Taka) and race TRANSONIC (J De Souza) with cover. When questioned by the Stewards regarding TRANSONIC's (J De Souza) previous history of pulling in the running, Trainer S Mahadia explained that he had worked this gelding with cover at trackwork and was of the opinion that this horse could race with cover.
The Stewards noted the explanations of Trainer S Mahadia and disseminated the riding tactics to the public.
2. An inquiry was opened in order to establish why CARLAS MAMBO (B Sooful) had to ease between the 1400m and 1300m. At an Inquiry held at the offices of the HRD on 16 November 2022, Jockey A L Da Silva was charged with a contravention of Rule 208 (d). Jockey Da Silva pleaded not guilty to the charge however, after hearing the evidence of the matter, the Stewards' Panel found him guilty as charged. A penalty of a suspension from riding in races for one race meeting was imposed. Suspension date: 26 November 2022. Jockey Da Silva has the right of appeal against the finding and penalty imposed.



3. OPAGUE (S Bussunt) raced wide around the turn and into the straight.
4. After the running of this race, the Stewards acting under Rule 33, stood down Jockey J De Souza (TRANSONIC). An inquiry was opened into Jockey J De Souza's riding of TRANSONIC in this race. At an Inquiry held at the office of the HRD on 15 November 2022, Jockey J De Souza was charged with a contravention of Rule 207 (a). Jockey De Souza pleaded not guilty to the charge however, after hearing the evidence of the matter, the Stewards' Panel found him guilty as charged. A penalty of a suspension from riding in races for a period of one year was imposed. Suspension dates: 16 November 2022 – 15 November 2023. Jockey De Souza has the right of appeal against the finding and penalty imposed.
5. After the race, Trainer A Sewdyal appeared before the Stewards and raised concerns about the conduct of another Trainer.

1. SHAH AKBAR (S Rama) raced wide in the early stages. Thereafter, this colt raced around the field and to the lead at the 1450m.
2. FAVOUR (S Bussunt) shifted out away from the whip from the 100m to the finish.
3. BAG OF TRICKS (R Joorawon) brushed the inside rail entering the straight. Thereafter, this gelding hung in, in the straight. After reviewing the patrol films of the race, no further action was taken against Jockey R Joorawon for his riding of BAG OF TRICKS in this race.
4. In view of the performance of SHAH AKBAR (S Rama), the Veterinary Surgeon was requested to examine.
5. Jockey S Rama signed an admission of guilt for a contravention of Rule 147A(a)(ii) in that he lost his whip at the 200m while riding SHAH AKBAR. Accordingly, a penalty of a fine of Rs 2000 was imposed.

Stewards Reports

1. UNDERCOVER AGENT (N Teeha) was ridden aggressively from the start in order to obtain a forward position. However, this gelding subsequently found no extra in the straight. In view of this report, the Veterinary Surgeon was requested to examine.
2. COLOUR MY FATE (J Da Silva) was ridden aggressively from the start and obtained the lead at the 1200m.
3. BLACKBURN ROC (R Joorawon) raced wide from the 400m and into the straight.
4. DYNAMITE JACK (S Rama) raced wide around the turn and into the straight.
5. At the 200m, CRANK IT UP (K Ramsamy) had to switch in, off the heels of UNDERCOVER AGENT (N Teeha).

1. At the 1100m, GLOBAL GLORY (R Joorawon), which initially raced outside the leader, elected to ease when awkwardly placed between SUGOI (A L Da Silva), which shifted out of the inside of the running rail whilst over-racing, and CLOUD SEEDER (J Da Silva) which elected to race forward from a wide position. This resulted in GLOBAL GLORY losing position behind SUGOI (A L Da Silva) which moved into the position outside the leader, and CLOUD SEEDER (J Da Silva) which raced to the lead after the pace slowed when Jockey L Goomany's (SPRY) saddle slipped forward at the 1100m. This saddle slip was confirmed by the Stewards on the patrol film.
2. BESTDAY OF MYLIFE (M P De Oliveira) shifted wide around runners entering the straight, in order to secure a clear running. Thereafter, this gelding finished its race off strongly.

Stewards Reports

1. Shortly after the start, KAROO LARK (I Taka), GUNSTON (A L Da Silva) and IDEAL SECRET (L Goomany) bumped when awkwardly placed on the outside of GRAND VISION (S Bussunt) which jumped out awkwardly, unbalanced and subsequently dislodged Jockey S Bussunt. This resulted in GRAND VISION galloping loose on the



course and GUNSTON (A L Da Silva) having to take evasive action in order to avoid the dislodged Jockey S Bussunt.

2. Between 1300m and 1100m, PRINCE OF VENICE (R Joorawon) raced keenly in the running.
3. From the 800m, KAROO LARK (I Taka) was forced to race wide after being carried out by GUNSTON (A L Da Silva) which rolled out off the inside rail.
4. GUNSTON and KAROO LARK (I Taka) raced wide around the turn and into the straight.
5. At the 200m, GUNSTON (A L Da Silva) was momentarily inconvenienced and at the 150m, RED MARS (B Sooful) was impeded, when both were awkwardly placed on the inside of the loose GRAND VISION, which shifted in.

GENERAL

1. Prior to the commencement of this race meeting, the Stewards walked the course and found it to be in good condition.
2. The Stewards acting under Rule 33, have stood down Jockey J De Souza for Race Meeting 33 scheduled on 13 November 2022. Trainers S Mahadia and Gujadhur were advised accordingly.
