**General**

1. Prior to the commencement of this race, the instructions for SMUTS (S. Rama), CHESTNUT COVE (J. Bardottier), DIGITAL FORTRESS (J. Allyhosain) and MISTY ROLLER (I. Taka) were taken by the Stipendiary Stewards. Trainer A. Sewdyal and Trainer N. Rawat advised the Board that their respective instructions to Jockey S. Rama and Jockey K. Kalychurun were to ride SMUTS and SUPREME ELEVATION with an intention to lead. These changes of tactic were disseminated to the public.

The instructions for DIGITAL FORTRESS and MISTY ROLLER matched the racing pattern of the horses.

**Starting Reports**

1. DIGITAL FORTRESS (J. Allyhosain) hesitated, jumped awkwardly and lost considerable ground.
2. POWER TOWER (I. Chisty) walked out of the gates, losing four lengths.

**Stewards Reports**

1. In view of the Starting Report, the starting stall certificate for DIGITAL FORTRESS (J. Allyhosain) has been withdrawn. This gelding has been suspended by the Stewards for seven days after which, it will be required to complete a jump out in a barrier trial to the satisfaction of the Stewards.
2. After losing considerable ground, DIGITAL FORTRESS (J. Allyhosain) trailed the field until entering the straight.
3. Jockey I. Chisty signed an admission of guilt for a contravention of Rule 29.2.15 in that he used his whip down the shoulder of POWER TOWER, whilst in the drawn position. Accordingly, a penalty of a fine of Rs 2,500 was imposed on him.
4. Jockey I. Chisty reported that POWER TOWER did not stride out freely in the running. In view of this report, the Veterinary Surgeon was requested to examine.
5. Jockey I. Chisty (POWER TOWER) appeared before the Board in relation to the lack of intent on the part of the Jockey to take an advantageous position leaving the stalls. He explained that this was the second run of the horse after an accident. The horse had jumped

well in its previous start, however, was sluggish this time and this was his second ride on this horse. Jockey I. Chisty was advised to show a positive intent in his future rides.

1. Jockey S. Rama was afforded the opportunity to explain his ride on JET STREAM. In this regard, he explained that his horse did not get a good jump, and since he was carrying 62kg, his intention was not to use his horse. Further, he was boxed with SUN TIGER (J. Bardottier) in front and CARINO BELLO (S. Bhundoo) on his left side and did not get an opening to progress in the race until about the 700m when he was able to maneuver his horse from behind CARINO BELLO. He also did not have an option to check his horse earlier than he did.

2. Jockey S. Bhundoo (CARINO BELLO) was questioned as to whether he could urge his horse to try and narrow the gap between him and the leader. Jockey S. Bhundoo stated that his horse was one paced and that he made his efforts to urge his horse to move forward, however, was not progressing in the race.
3. Jockey J. Bardottier (SUN TIGER) appeared before the Board and explained that his horse had jumped better today, was in a forward position and that he was satisfied with the positioning of his horse and rode SUN TIGER accordingly.
4. A review will be conducted into the running of this race.

In this regard, each of the instructions matched the racing pattern of the horses except for WINTER CHILL (I. Chisty) where Trainer A. Rahmathulla advised the Board that his instructions to Jockey I. Chisty is to ride WINTER CHILL with an intention to lead depending on how the horse would jump out. This change of tactic has been disseminated to the public.

### **Starting Reports**

1. WINTER CHILL (I. Chisty) jumped awkwardly.
2. ZIVA LA WINTER (B. Sooful) was slow by one length.

### **Stewards Reports**

1. Near the 1200m, ZIVA LA WINTER (B. Sooful) shifted ground out carrying GLOBAL GLORY (M. De Oliveira) wide who was steadied off the heels of WINTER CHILL (I. Chisty). In this regard, Jockeys B. Sooful and M. De Oliveira appeared before the Stewards. Jockey B. Sooful was shown the patrol films of the race and explained that his horse overraced and was on the heels of MASTER OF ILLUSION (J. Allyhosain), therefore, he had no option but to switch his mount out which resulted in GLOBAL GLORY being carried wider.

Jockey M. De Oliveira (GLOBAL GLORY) appeared before the Board and explained that leaving the stalls and after losing his reins momentarily, he found no room to hold his position and later on ZIVA LA WINTER (B. Sooful) carried him wider making him lose ground further. The Stipendiary Stewards deemed it a racing incident and did not proceed against any Jockey.

Trainer S. Mahadia appeared before the Board, was shown the patrol films of the race and conquered with the statements of Jockey M. De Oliveira. Nevertheless, a review will be conducted into Jockey M. De Oliveira's ride in this race.

2. Jockey B. Sooful reported that ZIVA LA WINTER did not stride out freely in the running. In view of this report, the Veterinary Surgeon was requested to examine.

## **ADDITIONAL INFORMATION**

### **1. Race Meeting 30 – 30 September 2023 – Race 3 - The RI Musical Family Cup**

Jockey B. Sooful signed an admission of guilt for a contravention of Rule 43.2.2 in that as the rider of the horse BESTDAY OF MY LIFE, he failed to ensure that he did not cause interference to LIVERPOOL CHAMP (R. Boutanive) at the 1300m. A suspension from riding in races for a period of one race meeting was imposed.

### **2. Race Meeting 31 - 1 October 2023 - Race 5 – The Maryse Justin Memorial Cup**

An inquiry held at the offices of the HRD on 13 October 2023, Jockey S. Donohoe (ROYAL VIRTUE) was charged with a contravention of Rule 43.2.2, in that, whilst riding his horse, he failed to ensure that he did not cause interference to GOOD BUDDY (D. Bheekary), CAPTAINS FORT (R. Oodith) and NEVIL MU (M. De Oliveira) at 600m.

Jockey S Donohoe pleaded not guilty to the charge, however, he was found guilty as charged.

After considering the evidence in this matter, the Inquiry Board imposed a penalty of a suspension from riding in races for one race meeting.

Jockey S. Donohoe has the right of appeal against the penalty imposed.

### **3. Race Meeting 31 - 1 October 2023 – Race 5 – The Maryse Justin Memorial Cup**

An inquiry held at the offices of the HRD on 11 October 2023, Jockey R. Joorawon (CAPTAIN LANNISTER) was charged with a contravention of Rule 43.2.2, in that, whilst riding his horse, he failed to ensure that he did not cause interference to COLOUR MY FATE (S. Rama) at 1300m.

Jockey R. Joorawon pleaded not guilty to the charge; however, he was found guilty as charged.

After considering the evidence in this matter, the Inquiry Board imposed a penalty of a suspension from riding in races for one race meeting and a fine of Rs10,000.

Jockey R. Joorawon has the right of appeal against the penalty imposed.



**4. Race Meeting 29 - 23 September 2023 – Race 3 – The Queen Victoria Youth Club Cup**

An inquiry held at the offices of the HRD on 11 October 2023, Apprentice I. Taka (HARDFALLINGRAIN) was charged with a contravention of Rule 43.2.2, in that, whilst riding his horse, he failed to ensure that he did not cause interference to BRABANZIO (R. Perez) at 1300m.

Apprentice I. Taka pleaded guilty to the charge.

After considering the evidence in this matter, the Inquiry Board imposed a penalty of a suspension from riding in races for one race meeting and a fine of Rs 5,000.

Apprentice I. Taka has the right of appeal against the penalty imposed.

**5. Race Meeting 24 - 9 August 2023 –Race 7 – The Solar Innovative Tech Limited Cup**

At an inquiry held at the Offices of the HRD on 25 August 2023, Jockey M. Chinapiel (COURTROOM MAGIC) was not found guilty of any contravention of a Rule due to insufficient evidence in the matter.

However, as an aftermath of this Inquiry, the Board resolved that Jockey M. Chinapiel be restricted to ride in races for Mauritian born Riders with less than 50 wins.

**6. Race Meeting 28 – 16 September 2023 - Race 3 - The Mare D'albert Celtic Association Cup**

Apprentice M. Sonaram signed an admission of guilt for a contravention of Rule 43.2.2 in that as the rider of the horse CAPTAIN PERSIA, he failed to ensure that he did not cause interference to FORT COMMANDER (C. Goolgar) at the 1000m. A penalty of a suspension of one race meeting and a fine of Rs 10,000 was imposed.
