Starting Reports

1. The start of the race was delayed due to XANTHUS (R K Chumun) having its saddle adjusted at the start.

Stewards Reports

- 1. MEZUZAH (B Sooful) raced awkwardly on heels in the early and middle stages. Thereafter, this gelding was hanging in, in the straight. In view of the performance of MEZUZAH, the Veterinary Surgeon was requested to examine.
- 2. LE QUARTIER (S Rama) raced wide into the straight.

Trainer C Daby and Jockey S Rama appeared before the Stewards and were questioned regarding the improved performance of LE QUARTIER. In this regard, Trainer C Daby could provide no explanation regarding the significantly improved performance of this gelding today. Trainer C Daby however, did explain that LE QUARTIER had improved on his behaviour of hanging and this had lead to an improvement in his work.

Jockey S Rama further explained, which was confirmed by Trainer C Daby, that he was of the view that this horse may have preferred the 990m, over which distance his last two runs were fair.

The Stewards noted the explanations of Trainer C Daby and Jockey S Rama. The consistency of the performances of LE QUARTIER will be monitored moving forward.

1. The start of this race was delayed due to AFRICAN FATE (L Goomany) proving difficult to load.

Starting Reports

1. AFRICAN FATE (L Goomany) proved difficult and reluctant to load.

Stewards Reports

- 1. In view of the Starting Report, the starting stall certificate for AFRICAN FATE (L Goomany) has been withdrawn. This gelding has been suspended by the Stewards for seven days after which, it will be required to complete a jump out in a barrier trial to the satisfaction of the Stewards. (Suspension dates: 14-20 November 2022)
- Leaving the 1050m, SIEGE RAM (N Teeha) which raced keenly in the running had to ease
 when racing onto the heels of ITALIAN WAY (D Schwarz), which elected to take cover
 after CARLTON HEIGHTS (J Da Silva) which was ridden aggressively from the start and
 ran to the lead at the 1100m.
- 3. SIEGE RAM (N Teeha) raced wide between the 450m and 300m.



Jockey J Da Silva (CARLTON HEIGHTS) appeared before the Stewards and was advised to take more care in future when shifting ground in races.

4. AFRICAN FATE (L Goomany) raced greenly in the running.

Starting Reports

- 1. CHOSEN WAY (N Teeha) lost a length.
- 2. TAKING SILK (K Ramsamy) and AMANDLA (D Bheekary) were slow into stride.

Stewards Reports

- 1. TALISMAN (D Schwarz) raced wide between 1850m and 1450m.
- 2. AMANDLA (D Bheekary) was difficult to settle in the early part of the race and as a consequence raced to the front at the 1300m.
- 3. At the 900m, LIVERPOOL CHAMP (R Joorawon) raced around the field and to the position outside the leader at the 700m.
- 4. At the 700m, TAKING SILK (K Ramsamy) had its hind quarter turn out when bumped out by CHOSEN WAY (N Teeha) which was bumped out by ARLINGTONS REVENGE (B Sooful), which shifted out. Any Inquiry has been opened into this incident.
- 5. TAKING SILK (K Ramsamy) and TALISMAN (D Schwarz) raced wide around the turn and into the straight.



- 6. CHOSEN WAY (N Teeha) hung out in the straight.
- 7. CHRISTMAS BAY (I Taka) shifted out away from whip in the concluding stages.
- 8. Trainer C Daby and Apprentice I Taka appeared before the Stewards and were questioned regarding the forward positioning of CHRISTMAS BAY in this race.

In this regard, both Trainer C Daby and Apprentice I Taka explained that it was their intent to race CHRISTMAS BAY in mid-field, however, after this gelding jumped better than the two speed horses on its inside, Apprentice I Taka elected to race in a forward position.

Trainer C Daby further pointed out that CHRISTMAS BAY had shown speed previously and the combination of the step up in distance and gate speed had enabled this horse to improve today.

The Stewards noted and accepted the explanations of both the Rider and Trainer.

9. Jockey B Sooful (ARLINGTON'S REVENGE) appeared before the Stewards and was questioned regarding his decision to direct ARLINGTON'S REVENGE out when there appeared to be sufficient room between himself and CHOSEN WAY. In this regard, Jockey Sooful explained that after entering the straight, his horse had shown a tendency to hang in. Accordingly, he elected to correct his mount with the right hand in order to direct ARLINGTON'S REVENGE away from CHOSEN WAY and give this horse an opportunity to balance up in the straight. The Stewards noted the explanation of Jockey Sooful.

- 1. SAN ANDREAS (B Sooful) and SAUNA'S CESSNA (S Rama) were slow into stride.
- 2. ROMANUS (N Teeha) lost one length.

Stewards Reports

- 1. At the start, Jockey J Da Silva (HIGH VOLTAGE) requested that the pacifiers be removed on HIGH VOLTAGE. This request was denied by the Stewards.
- 2. HOLLOW POINT (L Goomany) raced awkwardly between the 1300m and 1200m.
- 3. SAUNA'S CESSNA (S Rama) raced wide between 1300m and 900m.
- 4. From its wide draw, HIGH VOLTAGE (J Da Silva) raced wide whilst being ridden aggressively to obtain a forward position. This gelding briefly challenged NEW ABBEY for the lead leaving the 1200m however, it was not able to cross and had to settle in the position outside NEW ABBEY at the 1100m.
- 5. Approaching the 800m, ROMANUS (N Teeha) had to ease when awkwardly placed on the inside of HOLLOW POINT (L Goomany), which raced fiercely and shifted in.
- 6. GIRATORIO (D Schwarz) raced wide around the turn and into the straight.
- 7. ROMANUS (N Teeha) hung out in the straight.

1. ALRAMZ (N S Batchameah) was squeezed out at the start.

Stewards Reports

1. Prior to the running of this race, Assistant Trainer Mr. S Gujadhur for Mr. R Gujadhur advised the Stewards that due to the vast amount of early speed in this race, he elected to change the tactics on KAMADEVA (I Taka). In this regard, Apprentice I Taka was instructed to jump this gelding out the gates and rather than look for a forward position as is its norm, he was to secure running in a mid-field position.

Additionally, Trainer R Maingard appeared before Stewards and advised that for today's run he had instructed Apprentice N S Batchameah (ALRAMZ) to race in a rearward position early, and track horses into the race for as long as possible before showing this gelding daylight at the 150m.

The Stewards noted the tactics for both KAMADEVA (I Taka) and ALRAMZ (N S Batchameah) and disseminated such to the public.

- 2. LICKERIO (J Da Silva) raced wide throughout the running and faded in the straight.
- 3. Between the 1350m and 1250m, EMBLEM OF HOPE (A L Da Silva) and DUTCH ALLEY (M P De Oliveira) brushed on at least two occasions.
- 4. KAMADEVA (I Taka) raced fiercely between 1100m and 1000m.
- 5. EMBLEM OF HOPE (A L Da Silva) hung in, in the straight.
- 6. EMERALD BAND (D Schwarz) and DUTCH ALLEY (M P De Oliveira) were hanging in from the 200m.
- 7. D Schwarz (EMERALD BAND) lost his whip at approaching the 100m. Jockey D Schwarz was issued with a reprimand accordingly.

Suspension date: 26 November 2022 3 December 2022. Jockey Fayd'herbe has the right of appeal against the penalty imposed.
