1. HAPPY AND GLORIOUS (N S Batchameah) and INAUGURATION (B Bhaugeerothee) lost one length and two lengths, respectively.

#### **Stewards Reports**

- 1. Prior to this race, Assistant Trainer H K Gujadhur advised the Stipendiary Stewards that LIT (J Sophie) will be ridden aggressively and will test for the lead.
- 2. LIT (J Sophie) raced wide in the early stages.
- 3. OVERDOSE (M Sonaram) raced wide at the 300m and into the straight.
- 4. HAPPY AND GLORIOUS (N S Batchameah) shifted out away from the whip in the concluding stages.
- 5. Apprentice J Sophie (LIT) appeared before the Stipendiary Stewards, was shown the patrol films of the race and advised to ride his mounts out to the end of the race to the satisfaction of the Stipendiary Stewards so as to leave no room for query. In assessing what sanction to give to this matter, the Stipendiary Stewards noted that Apprentice J Sophie had fortuitously held his position at the finish and therefore a reprimand was issued.

#### **Stewards Reports**

- 1. At the 600m, TULLAMORE DEW (N Teeha) was carried in by LIQUID (B Sooful), which raced awkwardly and rolled in. Thereafter, at the 250m, Jockey N Teeha (TULLAMORE DEW) briefly dropped his right side rein.
- 2. ALAMEERY (R K Chumun) raced wide into the straight.
- 3. Between the 250m and the finish, LIQUID (B Sooful) shifted out away from the whip on at least two occasions.

Additionally, Jockey B Sooful signed an admission of guilt for a contravention of Rule 147(6)(a)(i) in that he struck the horse LIQUID with his whip more than once on consecutive strides in the running. Accordingly, a penalty of a fine of Rs 2500 was imposed.

- 2. SKIP THE RED (N S Batchameah) was held up for a clear run between the 400m and the 300m. Thereafter, this gelding was switched in to continue its run.
- 3. SAND PATH (M P De Oliveira) hung out between the 250m and the 100m.
- 4. At the 250m, GIGGIN (J De Souza) and SOCKEROO (S Bussunt) came together and bumped after both horses raced wide around the turn and into the straight. As a consequence of this bumping, at the 200m, SOCKEROO (S Bussunt) was momentarily inconvenienced when awkwardly placed on the outside of ZUM ZUM (I Taka), which shifted out away from the whip.
- 5. SOCKEROO (S Bussunt) hung in from the 150m.
- 6. SKIP THE RED (N S Batchameah) shifted out away from the whip in the concluding stages.

- 1. IDITAROD TRAIL (A Roy) lost two lengths.
- 2. ABSOLUTIST (J Da Silva) and HUBBLE (B Sooful) bumped and lost one length.

#### **Stewards Reports**

- 1. After jumping slowly, HUBBLE (B Sooful) which showed a tendency to lay in throughout the running, was ridden forward aggressively and obtained the lead at the 1300m.
- 2. ABSOLUTIST (J Da Silva) raced wide between the 1300m and the 1100m.
- 3. At the 1000m, BLACK CAT BACK (I Taka) was momentarily inconvenienced when awkwardly placed on the inside of MILLION DOLLAR MAN (J De Souza) which rolled in.
- 4. FOOLS GOLD (L Goomany) switched in to continue its run at the 250m. Thereafter, approaching the 150m, this gelding was tightened for galloping room when awkwardly placed on the inside of HUBBLE (B Sooful).
- 5. In the concluding stages, HUBBLE (B Sooful) was momentarily inconvenienced when awkwardly placed on the outside of FOOLS GOLD (L Goomany), which shifted out to continue its run when awkwardly placed on the heels of STREAM AHEAD (M P De Oliveira) which was hanging in, in the straight.
  - Jockey L Goomany (FOOLS GOLD) appeared before the Stipendiary Stewards, was shown the patrol films of the race and advised to take more care when shifting ground in races.

## Race 6 - (15h25) - THE PHOENIXBEV DUKE OF YORK CUP - G1 - 1600M (WFA) (10 Runners)

#### **Stewards Reports**

- 1. Prior to this race, Assistant Trainer H K Gujadhur advised the Stipendiary Stewards that Jockey B Bhaugeerothee (SHAH AKBAR) was to ride this colt forward but if challenged strongly, to obtain cover.
- 2. From draw 7, after jumping well, FROSTED GOLD (B Fayd'herbe) was allowed to stride forward in order to obtain a position one out and one back. Thereafter, at the 1450m, this gelding briefly overraced and took an awkward stride, at the 1250m, took the turn awkwardly, became momentarily unbalanced and had to be ridden to maintain its position. Turning for home, FROSTED GOLD (B Fayd'herbe) was angled out to the outer part of the course in order to make its run and stayed on to the finish. Jockey B Fayd'herbe subsequently reported however, that his mount did not produce its customary finishing burst.
- 3. From draw 8, UNDERCOVER AGENT (L Goomany) was ridden in order to obtain a forward position and subsequently obtained the lead leaving the 1300m. Thereafter at the 1000m, this gelding elected to take cover behind THE GATEKEEPER (R Joorawon). Entering the straight, UNDERCOVER AGENT was directed in and stayed on to finish fourth.



- 4. From draw 2, TWIST OF FATE (D Schwarz) was allowed to stride forward and obtained the position three back on the inside at the 1300m. Thereafter, this gelding was held up for a clear run between the 500m and the 300m behind SHAH AKBAR (B Bhaugeerothee). This gelding was only able to secure clear running between runners entering the straight, was directed to the middle of the course and finished its race off strongly to finish fifth.
- 5. From draw 6, after jumping slowly, ALYAASAAT (J Allyhosain) was restrained to a one-off position in second last. At the 800m, this gelding was briefly carried out wide by ROYAL WULFF (J De Souza). Thereafter, ALYAASAAT (J Allyhosain) was directed into a three deep running line to make its run from the 500m and the middle of the course in the straight, however, this horse weakened in the straight and ran nineth.
- 6. From draw 3, ROYAL WULFF (J De Souza) brushed with other runners out of the gates but was able to secure the position four back on the rail behind TWIST OF FATE (D Schwarz). Leaving the 1200m, this gelding had to ease momentarily when racing onto heels. Thereafter, at the 900m, ROYAL WULFF stumbled severely and shifted out after clipping the heels of TWIST OF FATE. Leaving the 500m, ROYAL WULFF was directed wide on the course in order to make its run, was positioned wide entering the straight and finished its race off fairly (sixth) despite shifting in away from the whip in the concluding stages.
- 7. From draw 5, THE GATEKEEPER (R Joorawon) jumped only fairly and brushed with other runners which resulted in it becoming momentarily inconvenienced when awkwardly placed on the inside of FROSTED GOLD (B Fayd'herbe). At the 1400m, after being caught three deep, Jockey R Joorawon elected to race around the field and to the lead at the 1000m. Entering the straight, THE GATEKEEPER (R Joorawon) was directed to the inside of the course and finished its race off well to finish second.
- 8. From draw 9, WALLS OF DUBROVNIK (A L Da Silva) brushed FAVOUR (S Bussunt) leaving the stalls. Thereafter, this gelding was allowed to stride forward and obtain the position outside the leader, which it held throughout the running



- until entering the home straight, when directed to the middle/inside part of the track and finishing its race off powerfully to win.
- 9. From draw 4, CRANK IT UP (K Ramsamy) was brushed by other runners leaving the starting stalls and was able to secure the position in the one off running line three back. Thereafter, this gelding was briefly inconvenienced on the heels of FROSTED GOLD (B Fayd'herbe) at the 1350m, tightened for galloping room at the 300m and after being directed in, in the straight, had nothing to come finishing tenth.
- 10. From draw 10, FAVOUR (S Bussunt) brushed with WALLS OF DUBROVNIK (A L Da Silva) and thereafter was restrained to last position on the rail. Subsequently, this gelding raced detached from the field between the 400m and 300m and after being directed in for its run in the straight, passed some runners to finish eighth.
- 11. From draw 1, SHAH AKBAR (B Bhaugeerothee) jumped best and led early before having to be steadied at the 1300m off the heels of UNDERCOVER AGENT (L Goomany). This resulted in SHAH AKBAR being positioned behind the leader on the rail. Thereafter, this colt came under pressure to keep pace with the leaders at the 400m and after being directed in, in the straight, gave ground to the placed runners and finished seventh.
- 12. An inquiry has been opened in order to establish why SHAH AKBAR (B Bhaugeerothee) had to ease at the 1300m.
- 13. An inquiry has been opened into Jockey A L Da Silva (WALLS OF DUBROVNIK) weighing back in after this race.
