Race 1 - (12h30) – THE ARMED GUARD CUP - (0-20) - 1500M (5 Runners)

Starting Reports

1. GREEK MYTH (I Taka) was stubborn to load.
2. JET PATH (M Chinapiel) was restless in the gates.

Stewards Reports

1. GREEK MYTH (I Taka) failed to negotiate the first turn. This resulted in this gelding racing wide between the 1200m and 1100m. Thereafter, GREEK MYTH (I Taka) hung in from the 200m.
2. JET PATH (M Chinapiel), which overraced in the early stages, raced wide between the 1200m and the 1000m.
3. Approaching the 1000m, LE QUARTIER (A Roy), which overraced early, was shifted out from behind runners entering the back straight and allowed to race forward. As a consequence of this decision, LE QUARTIER raced wide from the 600m to the 300m and into the straight.
4. AFRICAN FATE (N S Batchameah) hung in, in the concluding stages.
5. An inquiry will be opened in order to establish why LE QUARTIER (A Roy), ROCHESTER (S Bhundoo) and JET PATH (M Chinapiel) suffered varying degrees of interference after the start was effected.

Starting Reports

1. AL JAZEERA (M Sonaram) was restless in the gates.
2. SIEGE RAM (I Taka) and STREET BYTE (S Rama) brushed leaving the gates.
3. MOON JUMPER (J Sophie) jumped awkwardly and thereafter was slow into stride.

Stewards Reports

1. Prior to this race,
 - (i) Assistant Trainer H K Gujadhur advised the Stipendiary Stewards that MOON JUMPER (J Sophie) will be ridden to obtain a forward position from its draw, and
 - (ii) Trainer V Ruhee advised the Stipendiary Stewards that SIEGE RAM (I Taka) will not be ridden to lead in the early stages. However, in the event that the pace slackens in the middle stages, Apprentice I Taka was at liberty to race around the field in order to keep in touch with the front runners.

These changes of tactic were disseminated to the public.

2. HOLLOW POINT (L Goomany), which was hanging in, in the straight, shifted in away from the whip near the 100m. As a consequence of this incident, MOON JUMPER (J Sophie) was momentarily inconvenienced and had to shift out shortly before the finish. Jockey L Goomany (HOLLOW POINT) appeared before the Stipendiary Stewards, was shown the patrol films and advised to take more care when shifting ground in races in future.
3. STREET BYTE (S Rama) was hanging in, in the straight.

1. IMPERIAL RAGE (B Sooful) overraced in the early stages. Thereafter, this gelding shifted out, raced around the field and to the lead at the 1000m.
2. In order to avoid racing wide on the course, at the 400m, Apprentice N S Batchameah (EUROTEC) elected to switch in off the heels of LIVERPOOL CHAMP (J De Souza), which shifted out to continue its run.
3. At the 350m, TALISMAN (D Schwarz) was momentarily inconvenienced when awkwardly placed on the outside of CHRISTMAS BAY (I Taka), which was switched out to continue its run. Thereafter, CHRISTMAS BAY hung in between the 250m and the 100m.
4. Apprentice N S Batchameah (EUROTEC) appeared before the Stipendiary Stewards, was shown the patrol films of the race and was advised to ride his mounts out to the end of the



race to the satisfaction of the Stipendiary Stewards so as to leave no room for query. In assessing what sanction to give to this matter, the Stipendiary Stewards noted that Apprentice N S Batchameah had fortuitously held his position at the finish and therefore, a reprimand was issued.

General

1. The start of this race was delayed due to ILLICIT KISS (A L Da Silva) breaking through the stalls, having to be restrained by the rider, returned to the start, examined by the Veterinary Surgeon, passed fit to race and reloaded.

Starting Reports

1. SKIP THE RED (L Goomany) fly jumped.
2. At the jump, WATCH ME DAD (M P De Oliveira) and TULLAMORE DEW (I Taka) brushed.
3. ILLICIT KISS (A L Da Silva) broke through the gates, was restrained by the rider, returned behind the gates, passed fit to race and reloaded. Thereafter, this gelding jumped out and brushed the left-side gate.

Stewards Reports

1. In view of the Starting Report, the starting stall certificate for ILLICIT KISS (A L Da Silva) has been withdrawn. This gelding has been suspended by the Stewards for seven days after which, it will be required to complete a jump out in a barrier trial to the satisfaction of the Stewards. (Suspension dates: 11th to 17th December 2022)

2. At the 1100m, TULLAMORE DEW (I Taka) was bumped out by GLOBAL GLORY (J De Souza), which rolled out. Thereafter, TULLAMORE DEW (I Taka) raced wide for the remainder of the race.
3. WATCH ME DAD (M P De Oliveira) hung in throughout the running, proving difficult to assist. This behaviour placed Jockey M P De Oliveira at a significant disadvantage. Trainer C Daby will be advised to take all reasonable measures to correct the behaviour of this gelding.

1. TRIPPI'S EXPRESS (A L Da Silva) and NOURBESE (L Goomany) lost one length, respectively.

Stewards Reports

1. Between the 1200m and the 1100m, YOUR PACE OR MINE (J Bardottier) threw its head up on at least three occasions and was carried out by CAPTAIN FLYNT (M P De Oliveira), which hung out into the first turn.



2. At the 400m, TRIPPI'S EXPRESS (A L Da Silva), which raced wide throughout the running, was carried further wide by BLACKBURN ROC (I Taka), which switched out in order to obtain clear running. Thereafter, BLACKBURN ROC and TRIPPI'S EXPRESS were hanging in from the 200m.
3. AFDEEK (J Allyhosain) hung in from the 250m.
4. CAPTAIN FLYNT (M P De Oliveira) hung in from the 200m.
5. Approaching the 150m, PRINCE OF VENICE (M Sonaram) was briefly inconvenienced when awkwardly placed on the inside of YOUR PACE OR MINE (J Bardottier), which shifted in. As a consequence of this incident, OTTOMAN EMPIRE (S Rama) was momentarily inconvenienced when awkwardly placed on the heels of PRINCE OF VENICE, which had to shift out. Jockey J Bardottier appeared before the Stipendiary Stewards, was shown the patrol films and advised to take more care when shifting ground in races in future.

2. SUPREME ORATOR (J De Souza) was squeezed out at the start.

Stewards Reports

1. Prior to this race, Trainer V Ruhee informed the Stipendiary Stewards that Apprentice I Taka (WILDE WORLD) was instructed to lead. This information was disseminated to the public.



2. SPOTTED PEARL (L Goomany) overraced in the early stages.
3. Between the 1200m and the 1100m, SAUNA'S CESSNA (S Rama) had to be restrained off heels on at least three occasions when overracing.
4. When the pace of the race slowed marginally between the 1200m and the 1100m, LIT (J Sophie) which raced fiercely, had to ease severely when awkwardly placed on the heels of SAUNA'S CESSNA (S Rama).
5. SUPREME ORATOR (J De Souza) raced wide into the straight.
6. At the 200m, INAUGURATION (N Teeha) had to switch out when awkwardly placed on the heels of SPOTTED PEARL (L Goomany), which shifted in away from the whip. Thereafter, SPOTTED PEARL (L Goomany) raced with an awkward inward head carriage in the straight.
A race review was called into this incident by the Stipendiary Stewards. However, after viewing the patrol films of this race, no further action was taken.
7. BELIEVEINTHEFUTURE (A L Da Silva) hung in from the 200m.

4. All riders were breathalyzed today and cleared to race.
5. As part of its antidoping measures, the Stipendiary Stewards ordered sampling of the following horses approximately one hour prior to them racing:
Race 2 - MOON JUMPER and AL JAZEERA;
Race 4 - NAMIB DESERT and TRIP TO THE SKY.
