2. Shortly after the start, CHIEF RAFEEF (D Bheekary) was carried out by SPECIAL FORCE (A Sookhy), which jumped out sharply. As a consequence of this incident, Jockey A Sookhy (SPECIAL FORCE) lost his left and thereafter his right, stirrup iron which resulted in him being unable to assist his mount in the running.

3. CONSTITUTIONAL (R Joorawon) raced wide throughout. Thereafter, Jockey R Joorawon (CONSTITUTIONAL) reported that this gelding changed stride continually from the 400m and accordingly did not persevere with his riding from 300m. In view of this report, the Veterinary Surgeon was requested to examine.
4. CAPKUTA (S Rama) raced wide around the turn and into the straight. Thereafter, this gelding was hanging in from the 250m.

Starting Reports

1. CHESTNUT COVE (N Oodith) lost two lengths.
2. PIN DROP (S Rama) and LEAD SINGER (M Rashpassing) lost one length, respectively.
3. BENI DES DIEUX (M Sonaram) was slow into stride.

Stewards Reports

1. At the 1250m, DUKE OF ABERCORN (J Bardottier) had to ease when awkwardly placed between SERGEANT YORK (N S Batchameah) which rolled out and GONNABEALRIGHT (A L Da Silva), which rolled in whilst Jockey A L Da Silva was attempting to regain his right side stirrup iron which he lost at the 1300m. Thereafter, SERGEANT YORK (N S Batchameah) overraced in the early and middle stages.
2. YOHO MIST (J Da Silva) was ridden aggressively from the jump and obtained the lead at the 1100m.
3. LEAD SINGER (M Rashpassing) overraced in the early and middle stages of the race.
4. At the 150m, DUKE OF ABERCORN (J Bardottier) switched in to continue its run when awkwardly placed on the heels of BENI DES DIEUX (M Sonaram) which shifted out away from the whip and subsequently raced erratically in the straight.



Racecard Changes

1. Apprentice N S Batchameah (SERGEANT YORK) was only able to claim 2kg of his 3kg allowance and weighed out at 56kg.

1. The start of this race was delayed due to the false rails at the 1850m having to be adjusted.

Starting Reports

1. MIDNIGHT ORACLE (S Rama) had to ease when awkwardly placed on the outside of EXECUTIVE DECISION (R Joorawon) which jumped out. This resulted in both horses losing two lengths.



Stewards Reports

1. Prior to the start of this race, Trainer S Narang advised the Stipendiary Stewards that HEART OF DARKNESS (A Roy) will not be ridden to lead as he did not want to cut pace with ENIGMA CODE (I Taka) which he thought was faster. This change of tactic was disseminated to the public.
2. At the 1750m, EXECUTIVE DECISION (R Joorawon) had to ease when awkwardly placed on the inside of BYPASS (N Marday) which shifted in when awkwardly placed between THE HITMAN (A L Da Silva) which rolled out and SUBTROPICAL (K Ramsamy) which rolled in. Thereafter, EXECUTIVE DECISION (R Joorawon) raced fiercely in the early and middle stages of the race.
3. HEART OF DARKNESS (A Roy) overraced in the early and middle stages.
4. Jockey K Ramsamy reported that SUBTROPICAL was not striding out freely in the running and accordingly he did not persevere with his riding from the 500m. In view of this report, the Veterinary Surgeon was requested to examine.
5. MIDNIGHT ORACLE (S Rama) raced wide from the 500m to the 300m.
6. Between 250m and 100m, STONE CIRCLE (N S Batchameah) and ENIGMA CODE (I Taka) came together and bumped on two occasions.
7. At the 200m, HEART OF DARKNESS (A Roy) was carried in by THE HITMAN (A L Da Silva) which was hanging in, in the straight.

Stewards Reports

1. Prior to the start of this race, Trainer A Sewdyaal advised the Stipendiary Stewards that OVERDOSE (J Da Silva) will test for the lead. This change of tactic was disseminated to the public.
2. BELLAGIO KING (S Rama) raced wide throughout.
3. Between the 1300m and 1000m, GORDONSTOUN (R Joorawon) had to be eased off the heels of SYDS LIASON (I Taka) on a number of occasions when racing fiercely.
4. OXFORD BLUE (A Roy) raced wide from the 500m until turning for home.
5. SYDS LIASON (I Taka) shifted out shifted out away from the whip from the 200m.
6. Jockey J Bardottier reported that GONTRAVELIN did not striding out freely in the running and accordingly he did not persevere with his riding in the straight. In view of this report, the Veterinary Surgeon was requested to examine.
7. Jockey L Goomany appeared before the Stipendiary Steward and advised that with regard to LOCK DOWN (L Goomany), this gelding had not mustered the speed that he had anticipated, which resulted in this gelding racing further back in the running that he had anticipated which prejudiced his chances of winning the race.

1. In view of the Starting Report, the starting stall certificate for WELL CONNECTED (J Bardottier) has been withdrawn. This gelding has been suspended by the Stewards for thirty days after which, it will be required to complete a jump out in a barrier trial to the satisfaction of the Stewards. (Suspension dates: 18 December 2022 -16 January 2023).
2. BENEV (S Rama) raced wide between the 1300m and the 1100m.
3. CRIMSON GOD (J Da Silva) raced wide around the turn and into the straight.
4. WELL CONNECTED (J Bardottier) raced wide from the 500m until entering the straight.
5. ITDAWNEDONME (A L Da Silva) hung in, in the straight.
6. Jockey J Bardottier (WELL CONNECTED) was issued with a reprimand with regards to his whip use in this race.

CARBON FIBRE (N Oodith) raced intractably in the running, failed to respond to the urging of Jockey N Oodith, ducked out on the turn near the 1100m, was subsequently eased out of the race and was dismounted after the saddle on this colt slipped. The saddle slip was confirmed by the Veterinary Surgeon. In view of this horse's behaviour, CARBON FIBRE has been suspended from racing for seven days and until completing a gallop to the satisfaction of the Stewards and the Veterinary Surgeon.
2. CULTURE TRIP (D Bheekary) overraced in the early stages.



3. BATTLE OF ALESIA (K Ramsamy) hung in, in the straight.
4. Apprentice N S Batchameah (SPECIAL BLEND) rode his 30th winner and will only claim 2kg from the next race meeting.

1. BOLLINGER (M Sonaram), TICKET TO CAIRO (S Rama), GILBOA (K Ramsamy) and NOBLE TRIP (A L Da Silva) lost one length, respectively.

Stewards Reports

1. Prior to the start of this race, Trainer S Hurchund advised the Stipendiary Stewards that BONNIE PRINCE (D Bheekary) will be ridden with the intention to lead. This change of tactic was disseminated to the public.



2. Shortly after the start, Jockey D Bheekary became briefly unbalanced whilst riding BONNIE PRINCE. Thereafter, this gelding overraced in the early and middle stages.
3. CLOUD SEEDER (J Da Silva) overraced in the early stages.
4. NOBLE TRIP (A L Da Silva) raced wide in the early and middle stages of the race. Thereafter, at the 800m, Jockey A L Da Silva adjusted his right side stirrup iron.
5. DO OR DARE (I Taka) was restrained off heels at the 800m.
6. At the 900m, DOUBLE GAMES (D Schwarz) elected to race around the field and to the lead at the 700m.
7. GILBOA (K Ramsamy) became increasingly detached from the field from the 500m. Thereafter, Jockey K Ramsamy reported that GILBOA did not stride out freely in the running. In view of the performance of this gelding, the Veterinary Surgeon was requested to examine.
8. BOLLINGER (M Sonaram) raced wide into the straight.
9. TICKET TO CAIRO (S Rama) shifted out away from the whip between the 200m and the 100m.
10. An inquiry will be open in order to establish why BONNIE PRINCE (D Bheekary) and BOLLINGER (M Sonaram) suffered varying degrees of interference between the 700m and the 600m. At an Inquiry held at the offices of the HRD on 20 December 2022, Jockey A L Da Silva was charged with a contravention of Rule 208 (d). Jockey Da Silva pleaded not guilty to the charge however, was found guilty as charged. After considering the evidence in the matter, the Stewards imposed a penalty of a suspension from riding in races for a period of 3 race meetings. Jockey Da Silva has the right of appeal against the findings and penalty imposed.

1. The start of this race was delayed to the presentations.

Starting Reports

1. UNBELIEVABLE LAD (J Da Silva) jumped awkwardly and brushed the left side gate.
2. GIMME ACES (A Sookhy) jumped awkwardly and lost three lengths.
3. TIGER'S ROCK (M Rashpassing) lost one length.

Stewards Reports

1. UNBELIEVABLE LAD (J Da Silva) was ridden aggressively in order to obtain a forward position.
2. SENOR DON (J Bardottier) overraced in the early and middle stages.
3. TIGER'S ROCK (M Rashpassing) raced detached from the field in the early stages. Thereafter, at the 300m, TIGER'S ROCK (M Rashpassing) had to ease when awkwardly placed on inside of GIMME ACES (A Sookhy) which shifted in. Jockey A Sookhy (GIMME ACES) appeared before the Stipendiary Stewards, was shown patrol films of the race and was advised to take more care when shifting ground in races in the future.
4. GIMME ACES (A Sookhy) overraced in the early and middle stages and raced wide between the 500m and the 300m. Thereafter, this horse was hanging in, in the straight.
5. In the concluding stages, ONE DAY OR DAY ONE (I Taka) had to switch out in order to obtain clear running. Thereafter, this gelding finished its race off strongly.

6. Between the 250m and the 200m, THE JAZZ SINGER (A L Da Silva) which was hanging in, in the straight, was disappointed for a clear run when the gap between UNBELIEVABLE LAD (J Da Silva) and FLOWERSCAPE (M Sonaram) closed. Thereafter, Jockey A L Da Silva rather than switching out around heels, shifted his mount back in, in order to secure the clear running which had subsequently become available between runners. Jockey A L Da Silva appeared before the Stipendiary Stewards and was questioned with regard to his riding in the straight. In this regard, he confirmed in his explanation the aforementioned reading of the race.
