## THE RIVIERE DU REMPART SENIOR CITIZENS FEDERATION CUP

### RUN ON 08<sup>TH</sup> OCTOBER 2022

### RACE MEETING 26 - PEOPLE'S TURF PLC

An inquiry was held at the Office of the Horse Racing Division on 13<sup>th</sup> October 2022, and Jockey A L Da Silva (PRINCE ALF), who was accompanied by his Translator, was interviewed with regard to his riding in the race, specifically in the home straight.

Jockey A L Da Silva was interviewed with the specific reference to his inability to ride his horse from the outside of CANARY ISLAND and the reason for him to shift behind horses at top of the straight. The Jockey advised that his intention was to travel from the outside of CANARY ISLAND but his horse was awkward when straightened for home and then hung in. He found it difficult to pull his horse out and then he continued to ride his horse and also used the whip and he had not stopped riding any stage in the straight. The Stewards were satisfied with his explanation, in view of which the Stewards closed the matter.

#### RACE MEETING 26 - PEOPLE'S TURF PLC

An inquiry was held at the Office of the Horse Racing Division on 14<sup>th</sup> October 2022, and Apprentice M Sonaram (DAYLA VISTA) and Trainer R Maingard were interviewed in connection with a complaint lodged by Trainer R Maingard against the ride of Apprentice M Sonaram expressing his dissatisfaction since the Apprentice had not followed his instructions which were to obtain cover in the race.

Apprentice M Sonaram pleaded not guilty to the charge, however, he was found guilty of the contravention of Rule 208 (c) of the Rules of Racing, in that, when riding in a race, a Jockey shall follow his Trainer's instructions unless, for a good cause, he cannot do otherwise.

As a consequence, a penalty of suspension from riding in races w.e.f. 19<sup>th</sup> October 2022 up to 23<sup>rd</sup> October 2022, (both days inclusive), covering a period of 02 Race Meetings was imposed on him.

Apprentice M Sonaram was advised of his right to Appeal.

### RUN ON 08TH OCTOBER 2022

### RACE MEETING 26 - PEOPLE'S TURF PLC

An inquiry was held at the Office of the Horse Racing Division on 12<sup>th</sup> October 2022, and Jockey A L Da Silva (WALLS OF DUBROVNIK), who was accompanied by his Translator as well as Trainer S Hurchund, was interviewed with regard to his riding in the race, specifically between 900m and 600m.

Jockey A L Da Silva pleaded not guilty, however, he was found guilty of the contravention of Rule 208 (j) of the Rules of Racing, in that, when riding in a race, he did not ride his mount, throughout the race, to the satisfaction of the Stipendiary Stewards.

As a consequence, a penalty of suspension from riding in races w.e.f. 17<sup>th</sup> October 2022 up to 29<sup>th</sup> October 2022, (both days inclusive), covering a period of 03 Race Meetings was imposed on him.

Jockey A L Da Silva was advised of his right to Appeal.

## THE CASELA CUP, RUN ON 02ND OCTOBER 2022

## RACE MEETING 25 - MTC SPORTS AND LEISURE

Jockey S Bussunt (GRAND VISION) signed an Admission of Guilt with regard to GRAND VISION (S Bussunt) shifted out when ridden under the whip in the concluding stages of the race and taking the running of VAR'S ELUSION (A Andrews) when not sufficiently clear, causing VAR'S ELUSION to be checked and then GRAND VISION brushed with BACKPACKER (D Schwarz).

Jockey S Bussunt was found in contravention of Rule 208(d), in that, he failed to take every possible and all necessary steps to ensure that he or his horse did not cross, jostle, bunch, interfere with or intimidate another horse.

As a consequence, a penalty of suspension from riding in races for 02 Race Meetings was imposed on him, that is, with effect from 8<sup>th</sup> October 2022 to 15<sup>th</sup> October 2022.

## RACE MEETING 25 - MTC SPORTS AND LEISURE

Jockey B Sooful (JET PATH) signed an Admission of Guilt with regard to the shifting-in of JET PATH near 300m, taking the running of THE RIGHT STUFF (M P De Oliveira) who clipped the heels of JET PATH (B Sooful) and stumbled.

Jockey B Sooful (JET PATH) was found in contravention of Rule 208(d), in that, he failed to take every possible and all necessary steps to ensure that he or his horse did not cross, jostle, bunch, interfere with or intimidate another horse.

As a consequence, a penalty of suspension from riding in races for 02 Race Meetings was imposed on him, that is, with effect from 08<sup>th</sup> October 2022 to 15<sup>th</sup> October 2022.

# THE 23<sup>RD</sup> ANNIVERSARY OF MR LOVE SOLO ARTIST CUP, RUN ON 11<sup>TH</sup> SEPTEMBER 2022 RACE MEETING 20 – PEOPLES' TURF PLC LTD

Jockey GD Aucharuz (DESERT ILLUSION) was found in contravention of Rule 147 (6)(a)(i), in that, he had used the whip in consecutive strides in the running prior to the 100m mark in a race.

As a consequence, a penalty of a fine of Rs.3500 was imposed on him.

Jockey GD Aucharuz was advised of his right to Appeal.

### RACE MEETING 21 - MTC SPORTS AND LEISURE LTD

An inquiry was held at the Office of the Horse Racing Division on 21<sup>st</sup> September 2022 and Jockey A Andrews (CARTEL BOSS) was interviewed with regard to his riding between 600m and 400m, which, in the opinion of the Stewards, led to a severe interference to ALRAMZ (L Goomany).

Jockey A Andrews pleaded not guilty, however, he was found guilty of the contravention of Rule 208 (d) of the Rules of Racing, in that, he failed to take every possible and all necessary steps to ensure that he or his horse did not cross, jostle, bunch, interfere with or intimidate another horse.

As a consequence, a penalty of suspension from riding in races w.e.f. 26<sup>th</sup> September 2022 up to 22<sup>nd</sup> October 2022, (both days inclusive), covering a period of 05 Race Meetings was imposed on him.

Jockey A Andrews was advised of his right to Appeal.



## SUPPLEMENTARY REPORT FROM RACES RUN ON 11<sup>TH</sup> SEPTEMBER 2022

### RACE MEETING 20 - PEOPLES' TURF PLC LTD

An inquiry was held at the Office of the Horse Racing Division on 16<sup>th</sup> September 2022 with regard to the use of Blinkers for the first time without a test on ABSOLUTIST and CRIMSON GOD in the 3<sup>rd</sup> and 8<sup>th</sup> race respectively. Trainer A Sewdyal was interviewed. The Stewards did not pursue the matter as far as ABSOLUTIST was concerned.

Mr. A Sewdyal pleaded not guilty, however, he was found guilty of the contravention of Rule 115 (g) of the Rules of Racing, in that, no horse may be entered to race unless when it is to race for the first time in blinkers has undergone a test at the starting gates prior to racing. Consequently, a fine of Rs.5000 was imposed on Trainer A Sewdyal.

Trainer A Sewdyal was advised of his right to Appeal.

### RACE MEETING 19 - PEOPLES' TURF PLC LTD

An inquiry was held at the Office of the Horse Racing Division on 15<sup>th</sup> September 2022 and Jockey D Bheekary (ARNHEM LAND) was interviewed with regard to his riding in the home stretch, which, in the opinion of the Stewards, led to ARNHEM LAND, eventually Placed 4<sup>th</sup>, losing 3<sup>rd</sup> Place to AL'S LEGACY considering the short margin between the two horses.

Jockey D Bheekary pleaded not guilty, however, he was found guilty of the contravention of Rule 208 (j) of the Rules of Racing, in that, when riding in a race, a jockey shall ride his mount, though-out the race, to the satisfaction of the Stipendiary Stewards. As a consequence, a penalty of suspension from riding in races, w.e.f. 20<sup>th</sup> September 2022 up to 1<sup>st</sup> October 2022, covering a period of 03 Race Meetings, was imposed on him.

Jockey D Bheekary was advised of his right to Appeal.

### SUPPLEMENTARY REPORT FROM RACE 7,

#### THE AAPRAVASI GHAT CUP, RUN ON 16TH JULY 2022

#### RACE MEETING 9 - PEOPLES' TURF PLC LTD

Jockey A Andrews (GIMMETHERAIN) was interviewed with regard to the interference caused to KAYDENS PRIDE (M Sonaram) soon after the start wherein GIMMETHERAIN was observed to have shifted in from the outside of BONNIE PRINCE when not sufficiently clear of KAYDENS PRIDE due to which KAYDENS PRIDE was carried inwards and after a few strides KAYDENS PRIDE was checked by its Rider. Jockey A Andrews's plea that KAYDENS PRIDE itself raced unsettled soon after the start was also considered.

After consideration of all facts of the case, Jockey A Andrews pleaded guilty of contravention of Rule 208 (d) of the Rules of Racing, in that, he failed to take every possible and all necessary steps to ensure that he or his horse did not interfere with another horse and was given an admission of guilt.

As a consequence, a penalty of a fine of Rs.5,000 was imposed on him.



Jockey B Sooful signed an admission of guilt for a contravention of Rule 208 (d) of the Rules of Racing in that he failed to take every possible and all necessary steps to ensure that he or his horse did not cross, jostle, bunch, interfere with or intimidate another horse and as a consequence a penalty of suspension from riding in races for one Race Meeting was imposed on him.
